### SUBJECT: General Manager's Status Report for the Month of June 2020

Paul G. Peschel, P.E., General Manager

This memorandum was prepared to supplement the monthly reports of the District's management team and to highlight specific items and activities for the month of June 2020.

### State Affairs

#### Legislative

The Assembly began their annual summer recess on June 19<sup>th</sup>, and the Senate July 2<sup>nd</sup>. Both houses reconvene on July 13<sup>th</sup>, and August 31<sup>st</sup> is the last day for both houses to pass bills for the Governor's consideration. The Governor has through September 30<sup>th</sup> to either sign or veto bills.

#### Bills

Staff are monitoring several bills (see attachment). Below are updates on new bills or bills that have had activity during the month of June.

#### SB 1215 (Stern D)

Electricity: microgrids – As amended, this bill requires the Public Utility Commission, in consultation with the Office of Emergency Services, to create a database of critical facilities and critical infrastructure, along with related critical circuits, and identify with respect to each whether it serves a high fire-threat district or vulnerable transmission area. The new amendments remove those sections viewed favorable for Kings River interests. The bill is now on the suspense file. Kings River Legislative Committee does not have a position.

#### SB 1099 (Dodd D)

Emergency backup generators: critical facilities: order for abatement: stipulations – Emergency backup generators: critical facilities: exemption. Co-sponsored by California Municipal Utilities Association and the Las Virgenes Municipal Water District. The bill would require air districts to grant a variance if there is an exceedance in runtime during a Public Safety Power Shutoff, and for testing and maintenance hours if they exceed the limit but are in compliance with National Fire Protection Association (NFPA) Standard 110. A five-year sunset clause is included and the Energy Commission is required to perform a study on emergency backup generation options and opportunities to transition to clean energy technologies. This bill has been amended and now requires operators to petition the local Air Quality Management District to allow certain exemptions in times of emergency. Kings River Legislative Committee has a favor position.

### SB 350 (Hill D) The Golden State Energy Act

This bill would authorize the Governor, or the Governor's designee, to incorporate Golden State Energy (GSE) as a nonprofit public benefit corporation for the purpose of owning, controlling, operating, or managing electrical and gas services for its ratepayer and for the benefit of all Californians. Specifically, the bill would require the California Public Utilities Commission (CPUC) to Board of Directors July 7, 2020 Page 2

begin the process of conforming PG&E's rules and processes with those of GSE within 45 days should PG&E fail to obtain confirmation of their reorganization plan by June 30<sup>th</sup>, fail to exit bankruptcy by September 30<sup>th</sup>, the CPUC revokes PG&E's license at any time for failure to achieve safe operation of its system, or should PG&E decide to exit the business and sell its assets before the conclusion of the bankruptcy. This bill was signed by the Governor on July 1 and chaptered. KRCD had a watch position.

## ACWA State Legislative Committee

I attended the June 26<sup>th</sup> meeting. Five bills were discussed. In addition to the bills, the upcoming virtual conference, ACWA's return-to-office strategy, drinking water funding, and several Federal items were discussed. One item of concern mentioned is that the California Air Resources Control Board is moving forward with a regulation – Advanced Clean Trucks – that will require entities with a fleet of 50 or more trucks, and all local agencies with truck fleets of any size, to convert all their trucks to electric.

## San Joaquin Valley Blueprint (SJVB)

A Blueprint meeting was held on June 18<sup>th</sup>. Fresno State presented a Detailed Work Plan for providing drinking water for Disadvantaged and Severely Disadvantaged communities. Water would be diverted from the Madera and Friant-Kern canals to groundwater recharge projects and other types of facilities, with the intent to improve drinking water conditions (accessibility, affordability, quality and quantity). The Study Area is Madera, Fresno, Kings, Tulare, and Kern counties. The study will also review benefits for White Areas and Groundwater Dependent Ecosystems. Water supply availability will be reviewed for five types of hydrologic conditions for the San Joaquin, Fresno, Chowchilla, Kings, Tule, Kaweah, and Kern rivers.

Attached is the current Blueprint Project List.

## Budget

The Legislature met its Constitutional obligation to pass a balanced State budget by June 15<sup>th</sup>. The budget represents Democratic majority priorities and does not contain many of the Governor's preferences for addressing the projected \$54 billion deficit. Negotiations continued with the Governor through adoption with the understanding that adoption will be followed by a true-up and an August revision.

The Cap-and-Trade Program is not included in the budget. Neither is any General Obligation Bond to fund climate resiliency, clean water, groundwater cleanup, or infrastructure construction/protection efforts. The budget does include a potential draw on the General Fund to allocate \$10 billion, over five years, to several existing housing, homelessness, and pre-apprenticeship programs, as well as creating two new infrastructure financing programs within the Governor's Office of Business and Economic Development.

A proposal to establish a new climate resiliency fund is contained in trailer bill AB 78, which has been signed into law. Another trailer bill regarding 401 Water Quality Certification, AB 92, provides the State Water Resources Control Board with the ability to impose CEQA mitigation requirements after issuance of a 401 certification. This was in reaction to a court decision requiring state environmental review agencies to complete their processes associated with FERC relicensing applications within a year or be found to have waived jurisdiction. The trailer bill language was far too broad and would have placed FERC applicants in additional process jeopardy. These deficiencies have been minimized with language modifications to AB 92 which now specifies how and why the State can re-open certification. The modified version of AB 92 has been signed into law.

The annual Budget and Trailer Bill chart is attached. All bills on the chart have been enrolled and presented to the Governor. The Governor has 12 working days to use his "Blue Pencil," which gives him line-by-line veto authority to reduce or eliminate any appropriation contained in the budget. The Legislature can override any blue-penciled item by a 2/3 vote in both houses. In practice, the Legislature rarely overrides a budget veto.

## Bonds

It does not appear that bond legislation will be successful this year. SB 45 (Allen D) Wildfire Prevention, Safe Drinking Water, Drought Preparation, and Flood Protect Bond Act of 2020 is still at the Assembly Desk waiting to be referred. AB 3256 (Garcia, Eduardo D) Climate risks bond measure is still in the Assembly.

## Regulatory

## Drinking Water and Clean Water State Revolving Funds

The State Water Board adopted planning and funding documents for the Clean Water and Drinking Water State Revolving Fund Programs for Fiscal Year 2020-21. Millions of dollars in low interest and principal forgiveness loans are provided to dozens of communities throughout California. More than \$1.2 billion in potential new funding were approved. The Clean Water State Revolving Fund intended use plan adds up to \$910 million, and the Drinking Water State Revolving Fund intended use plan is in excess of \$308 million for new projects. The respective revolving fund programs and plans are adopted annually, which is now entering its third decade with drinking water and fourth decade for clean water projects. All projects are directly related to protecting or improving public health, water quality, or both.

### SWRCB Fees

Bob Gore and I had three meetings with State officials. The officials were Patrick Pulupa Central Valley Regional Water Quality Control Board Executive Officer; Andrew Altevogt, State Water Resources Control Board (SWRCB) Division of Drinking Water Assistant Deputy Director; and Karen Mogus, SWRCB Deputy Director in charge of the Division of Water Quality. The conversations were followed with letters and a background support document (attached). Additional meetings are being coordinated.

### Federal District Court Denies Motion for Preliminary Injunction as to Shasta Dam Operations

On June 24<sup>th</sup>, the United States District Court for the Eastern District of California denied the preliminary injunctive relief requested by a coalition of fishery and environmental groups (Plaintiffs) regarding the U.S. Bureau of Reclamation's (Reclamation) operations of Shasta Dam and Reservoir, and related temperature management actions on the upper Sacramento River. This denial followed the court's previous May 11<sup>th</sup> order in the case granting a three-week injunction as to Central Valley Project (CVP) export pumping operations from the Sacramento-San-Joaquin Delta.

The Plaintiffs sought the injunctive relief as part of their pending challenge to the validity of the 2019 Federal biological opinions (BiOps) issued by the National Marine Fisheries Service (NMFS) and the United States Fish & Wildlife Service for the long-term operation of the CVP and State Water Project (2019 BiOps). The Plaintiffs argued that the CVP operations covered under the 2019 BiOps would jeopardize the continued existence of Endangered Species Act listed species (including listed winterrun and spring-run Chinook salmon), and therefore the court should restore the previously controlling 2008 and 2009 BiOps that were in place prior to being replaced by the 2019 BiOps. In this regard, Board of Directors July 7, 2020 Page 4

Plaintiffs specifically requested that the court require Reclamation to perform certain actions as required under the 2009 NMFS BiOp in order to avoid alleged temperature dependent mortality to winter-run and spring-run salmon during the egg-to-fry life stage in the upper Sacramento River.

## Other

Miranda Flores, 37, of Folsom, has been appointed deputy secretary of legislation at the California Natural Resources Agency. Flores has been legislative director in the Office of State Assemblymember Bill Quirk since 2017, where she held several positions from 2012 to 2017, including interim chief of staff, legislative aide, and executive assistant. She was executive assistant in the Office of State Senate President pro Tempore Darrell Steinberg from 2010 to 2012, office manager and scheduler in the Office of State Senator Jenny Oropeza from 2008 to 2010, and lead capitol security technician for the California State Senate Sergeant-at-Arms from 2003 to 2008. This position does not require Senate confirmation. Flores is a Democrat.

## Federal Affairs

Both the House and Senate are in session. The House is operating with new proxy voting rules in place. Both chambers continue to work on legislation of importance to Kings River, including legislation to reauthorize the Water Resources Development Act (WRDA) and legislation aimed at Reclamation programs and western water issues.

### Legislative

## COVID-19

July will be a critical month for discussions about additional coronavirus relief legislation as both chambers finalize proposals and discussions continue with the White House on where and how much funding is needed. Senate Majority Leader Mitch McConnell (R-KY) recently stated he sees the potential for Congress to pass another coronavirus response bill sometime this summer. However, aside from discreet proposals outlined in standalone legislative proposals, no comprehensive relief package has been developed by either the House or the Senate.

The Federal Reserve created the Municipal Liquidity Facility (MLF) program in response to the coronavirus pandemic to provide short-term loans to state and local governments with at least an A-credit rating. However, the program provides loans to only a maximum of two special districts per state. California has 1,913 special districts alone. Senators Dianne Feinstein and Kamala D. Harris, while noting that special districts have suffered substantial revenue losses as a result of COVID-19, sent a letter (attached) to the U.S. Department of Treasury and Federal Reserve calling for the removal of the cap limiting special district access to the MLF. In addition, Representative John Garamendi (CA-D) introduced the Special Districts Provide Essential Service Act (H.R. 7073) that provides special districts access to the MFL with no limitations. H.R. 7073 also establishes a 5% set aside of all future coronavirus relief funding for special districts, and provides a Federal definition of the term "special district."

The White House Office of Management and Budget (OMB) asked Federal agencies to prepare lists of regulations by June 23<sup>rd</sup> that may inhibit economic recovery during the pandemic. The lists are to include temporary regulatory actions agencies have taken in response to the COVID-19 pandemic that warrant the issuance of a permanent measure to promote economic recovery. Potentially targeted regulatory actions could include labor, energy, and environmental regulations, but the impacts of the memo on these regulations are uncertain.

## Corps Bills

## Water Resources Development Act

In May, the Senate Environment and Public Works Committee passed the Senate's version of the Water Resources Development Act (WRDA) legislation which includes the S. 3591, America's Water Infrastructure Act (AWIA), and S. 3590, the Drinking Water Infrastructure Act (DWIA). The House is still preparing its version of a WRDA reauthorization bill. The release of the draft legislation, as well as a mark-up of the bill, is expected to occur in July. After the House and Senate pass their individual bills, a reconciliation of the bills will occur in a conference committee. This year's bills will consider economic recovery, so WRDA could be incorporated into a more comprehensive economic recovery infrastructure package. As such, in the Senate, Environment and Public Works Chairman John Barrasso (R-WY) has pushed for merging his Environment and Public Works Committee's highway, drinking water and water projects (AWIA and DWIA) bills into a broad infrastructure package that could pair with but remain different from the House version. The recently House-passed Moving Forward Act (H.R. 2), mentioned above, does not include WRDA. Any incorporation of WRDA into a broader public infrastructure package will come later.

## **Reclamation Bills**

Staff are monitoring several bills (see attachment). Below are updates on new bills or bills that have had activity during the month of June.

On July 2<sup>nd</sup>, the House of Representatives passed a \$1.5 trillion comprehensive infrastructure package. The Moving Forward Act (H.R. 2) includes \$65 billion for water projects, over \$25 billion for the Safe Drinking Water State Revolving Fund and other drinking water programs, and \$40 billion for wastewater infrastructure. The bill would reinstate advance refunding bonds and Build America Bonds, create new direct payment bonds, and exempt water infrastructure projects from the state allocation caps for Private Activity Bonds. The package also includes investments in modern water infrastructure for drought preparedness and improved water supply reliability and contains specific provisions related to western water supply. The House transportation reauthorization bill served as the base text of H.R. 2.

The package was not received well by the Senate or the White House, with immediate opposition from Senate Republicans, including Senate Majority Leader Mitch McConnell who declared the package dead on arrival in the Senate. The White House also issued a veto threat for the bill. Thus, the bill is not expected to advance past the House, but does provide the basis for negotiations on a final package from which both chambers and the Trump Administration can work. In that regard, work on a package is expected to continue through the summer and possibly into the fall. As such, the Trump Administration continues to express interest in a \$1 trillion infrastructure plan as outlined in the President's Fiscal Year 2021 budget proposal. KRCD staff are working with The Ferguson Group to identify projects that fit under funding categories to help legislators understand our funding needs for public infrastructure. Categories include projects under SGMA, fisheries, water quality, and maintenance.

In developing H.R. 2, House Democrats incorporated either the full or partial text of bills previously approved or introduced in the House, including bills currently being tracked by Kings River. These bills included:

- No previous bill number FUTURE Drought Resiliency Act (Representative Huffman)
- H.R. 5316 Move Water Now Act (Representative Cox (D-CA))
- H.R. 3723 Desalination Development Act (Representative Levin (D-MI))

- H.R. 5347 Disadvantaged Community Drinking Water Assistance Act (Representative Cox (D-CA))
- H.R. 1163 Water Recycling Investment and Improvement Act (Representative Napolitano (D-CA))
- H.R. 4891 Western Water Security Act of 2019 (Representative Torres Small (D-NM))
- H.R. 2473 SAVE Water Resources Act (Representative Harder (D-CA)) Only groundwater recharge planning provisions were included in H.R. 2.

The Senate passed the "Great American Outdoors Act," S. 3422 /H.R. 1957 on June 17, 2020 by a vote of 73-25. The bill permanently and fully funds the Land and Water Conservation Fund for the first time since it was created in 1964 at \$900 million annually, paid for by offshore oil and gas revenue. The bill also creates a five-year trust fund to draw down some of the \$20 billion backlog of deferred maintenance projects at national parks and other public lands around the country that are managed by the Department of the Interior. There was a major push to amend the bill to, among other things, remove a cap on how much offshore oil and gas revenue Gulf states can receive and put toward restoring their eroding coastlines. However, Senate Leadership decided not to allow any amendments to be considered during final debate. The bill now moves to the House, where bipartisan passage is expected, and then to the President who is expected to sign the bill into law.

## Other Bills

The following Deregulatory legislation was introduced by congressional Republicans.

- S. 3926 (Senators Cruz (R-TX), Cotton (R-AR), Lankford (R-OK)) would amend the FAST Act to give project proponents more control over the permitting timetable and prevent litigation from unnecessarily holding up projects;
- S. 3927 (Senators Cruz (R-TX), Cotton (R-AR), Lankford (R-OK)) would reduce the time that project opponents could challenge a project's Federal permit or approval in court from 150 days to 90 days;
- S. 3922 (Senator Paul (R-KY)) would establish Federal regulatory review commissions;
- H.R. 7130 (Representative Davis (R-IL)) to codify the president's 2017 executive order, which consolidated the environmental review process across Federal agencies;
- H.R. 6691 (Rep. Roy (R-TX)) would permanently repeal any Federal regulations waived during the COVID -19 pandemic.

## ACWA Federal Affairs Committee

I attended the Federal Affairs Committee on June 24<sup>th</sup>. 18 bills were reviewed, along with several items which are included in the other Federal Affairs sections of this report. One item of note: ACWA sent a letter (attached) to House and Senate leadership on June 26<sup>th</sup> that calls for investment in water infrastructure funding to help local economies recovery from COVID-19 pandemic.

## Budget

## USDA ARS (Agricultural Research Service) Snow Research

The Ferguson Group continues to work with Senator Feinstein's and Representative Harder's offices, as well as the Bureau of Reclamation, on legislation to authorize funding for the ARS program and Aerial Snow Observatory (ASO) activities.

### 2021 Appropriations

The House Appropriations Committee plans to begin marking-up Fiscal Year 2021 spending bills beginning the week of July 6<sup>th</sup>, with subcommittee markups for Interior and Energy & Water Development on July 7<sup>th</sup>. The Energy & Water Development and Interior-Environment bills are

expected to be reported out of full committee on July 10<sup>th</sup>. The Senate markups of Fiscal Year 2021 spending bills have been delayed due to policy disagreements over Democratic proposed COVID-19 and policing amendment riders. Senate Republicans do not believe these controversial amendments belong in spending bills, while Senate Democrats want to highlight their differences with the Majority party before the November elections. If the impasse continues, a temporary continuing resolution (CR) would be necessary to keep the government open after September 30<sup>th</sup>.

## Regulatory

## Waters of the United States (WOTUS) and Navigable Protection Rule.

The Trump Administration published their final Navigable Waters Protection Rule: Definition of "Waters of the United States" (WOTUS) rule in the Federal Register (FR) on June 29<sup>th</sup>. The rule, which was finalized in January, will take effect in 60-days from publication. This move also allows for litigation to be filed against the Administration and the final rule.

Speaking of WOTUS litigation, although they appear to have jumped the gun regarding the 60-day publication requirement, various groups have filed litigation against the U.S. Environmental Protection Agency and the Army Corps of Engineers challenging the Clean Water Act revisions. The Natural Resources Defense Council (NRDC) – joined by seven other environmental groups from Wisconsin, New Mexico and elsewhere – filed a challenge in a Federal district court in Massachusetts. A lawsuit was filed by more than a dozen national and local environmental organizations in the Federal district court in South Carolina. A Federal judge in San Francisco denied a motion by a coalition of Democratic state attorneys generals to issue a nationwide injunction of the Trump Administration's new regulation. The judge ruled that the plaintiffs did not show they had a strong enough challenge to the Navigable Waters Protection Rule to warrant a preliminary injunction. Shortly after that ruling, a Federal judge in Colorado granted that state's request to put implementation of the WOTUS rule on hold in that state. Also, a coalition of Native American tribes and environmental groups have filed two more lawsuits challenging the new WOTUS rule.

## State

*AB 352 (Garcia D)* Wildfire Prevention, Safe Drinking Water, Drought Preparation, and Flood Protection Bond Act of 2020--Would enact the Wildfire Prevention, Safe Drinking Water, Drought Preparation, and Flood Protection Bond Act of 2020, which, if approved by the voters, would authorize the issuance of bonds in the amount of \$3,920,000,000 pursuant to the State General Obligation Bond Law to finance a wildlife prevention, safe drinking water, drought preparation, and flood protection program. The bill would provide for the submission of these provisions to the voters at the November 3, 2020, statewide general election.

AB 916 (Muratsuchi D) **Pesticide use: glyphosate**.--Would, until January 1, 2025, prohibit a city, county, charter city, city and county, or a special district, as defined, from using any pesticide that contains the active ingredient glyphosate. The bill would not preclude a county, city, charter city, city and county, or a special district from adopting or enforcing stricter pesticide use policies.

Ab 3256 (Garcia D) **Climate risks: bond measure--**The California Drought, Water, Parks, Climate, Coastal Protection, and Outdoor Access For All Act of 2018, approved by the voters as Proposition 68 at the June 5, 2018, statewide direct primary election, authorizes the issuance of bonds in the amount of \$4,000,000,000 pursuant to the State General Obligation Bond Law to finance a drought, water, parks, climate, coastal protection, and outdoor access for all program. This bill would state the intent of the Legislature to enact a bond measure that would address climate risks to the State of California.

ACA 3 (Mathis R) **Clean Water for All Act--**This measure, the Clean Water for All Act, would additionally require, commencing with the 2021–22 fiscal year, not less than 2% of specified state revenues to be set apart for the payment of principal and interest on bonds authorized pursuant to the Water Quality, Supply, and Infrastructure Improvement Act of 2014; water supply, delivery, and quality projects administered by the department, and water quality projects administered by the state board, as provided.

SB 45 (Allen D) **Wildfire Prevention, Safe Drinking Water, Drought Prep, and Flood Protection Bond Act of 2020--**Would enact the Wildfire Prevention, Safe Drinking Water, Drought Preparation, and Flood Protection Bond Act of 2020, which, if approved by the voters, would authorize the issuance of bonds in the amount of \$5,510,000,000 pursuant to the State General Obligation Bond Law to finance projects for a wildfire prevention, safe drinking water, drought preparation, and flood protection program.

SB 69 (Wiener D) **Ocean Resiliency Act of 2019**--Current law requires the Fish and Game Commission to establish fish hatcheries for the purposes of stocking the waters of California with fish, and requires the Department of Fish and Wildlife to maintain and operate those hatcheries. This bill would require the department to develop and implement a plan, in collaboration with specified scientists, experts, and representatives, as part of its fish hatchery operations for the improvement of the survival of hatchery-produced salmon, and the increased contribution of the hatchery program to commercial and recreational salmon fisheries.

SB 559 (Hurtado D) **California Water Commission: grant: Friant-Kern Canal--**Under current law, the United States Bureau of Reclamation operates the federal Central Valley Project and the Department of Water Resources operates the State Water Project to supply water to persons and entities in the state. Current law establishes the California Water Commission, consisting of 9 members appointed by the Governor, in the department. This bill would require the commission to make a grant of \$400,000,000 to a specified joint powers authority to restore the capacity of the

Friant-Kern Canal, subject to an appropriation. The bill, among other things, would require the grant to be part of a comprehensive solution to groundwater sustainability and subsidence in the San Joaquin Valley and would require the joint powers authority to demonstrate a funding match of at least 35% from user fees, local sources, federal funding, or a combination of these sources.

SB 797 (Wilk R) **Water resources: permit to appropriate: application procedure--**Current law requires the State Water Resources Control Board to issue and deliver a notice of an application as soon as practicable after the receipt of an application for a permit to appropriate water that conforms to the law. Current law allows interested persons to file a written protest with regard to an application to appropriate water and requires the protestant to set forth the objections to the application. Current law declares that no hearing is necessary to issue a permit in connection with an unprotested application, or if the undisputed facts support the issuance of the permit and there is no disputed issue of material fact, unless the board elects to hold a hearing. This bill, if the board has not rendered a final determination on an application for a permit to appropriate water within 30 years from the date the application was filed, would require the board to issue a new notice and provide an opportunity for protests before rendering a final determination, with specified exceptions.

While KRCD and our constituent farmers focus on SGMA, recharge, the ILRP, CV-SALTS requirements, and ensuring a sustainable water supply for the disadvantaged and disadvantaged communities, a key challenge is the myriad of fees and regulations faced by farmers, including water quality fees and regulations.

Although not critical to meeting current CV-SALTS and ILRP requirements, KRCD is independently exploring proceeding with a comprehensive and multi-benefit water resource study. Currently the study is envisioned to include well assessments in terms of facility make-up, water quality, water levels, and other data. The results of this effort would create a foundation from which issues, concerns, and problems can be clearly identified. Data generated will inform interim and ultimately long-term solutions where plans can be developed and implemented.

Receiving funding support for the various study stages (the study, interim, and long-term solutions) would be ideal, The study and associated solutions would not only benefit the ILRP and CV-SALTS (nitrate and salts), but provide critical data and solutions for mitigating other constituents of concern, which may assist in monitoring SGMA's undesirable results and help IRWM constituents with similar water resource solutions. KRCD's goal is to move forward with this effort on a parallel course with CV-SALTS implementation. Any assistance you can provide in terms of advice, direction, support, or funding avenues would be greatly appreciated.

Another multi-benefit program we discussed was the Airborne Snow Observatory (ASO). ASO provides a near-perfect assessment of snow water content and improves forecasting with accuracy through 10-days. Thus, this new tool is critical for accurate and greatly improved snowpack and runoff predictions. With climate change and numerous other factors impacting water resources, this is a critical tool that has proven multiple benefits and is paramount to continue to fund and utilize. Benefits include helping mitigate water quality, drinking water, environmental (fishery, groundwater connected ecosystems, and others), flood control, water supply, and climate change impacts across all these and other water resource related elements.

Funding for ASO was moved from NASA to a private entity. Per flight costs are approximately \$150,000, with multiple flights required per season, and an additional \$20,000 per flight to receive vital modeling. State funding for the program was proposed, but was removed from the State budget. We realize this program does not fall under your purview, but it will benefit the programs under your purview. As such, we ask for any support you can provide to help establish and maintain funding.

## Agency Profile

Established in 1951 by a special act of the State legislature, the Kings River Conservation District is a multi-county, special district formed to manage the lower Kings River watershed, serving all the constituents within 1.2 million acres in portions of Fresno, Kings and Tulare counties. KRCD is governed by an elected board of seven directors. The District is a collaborative resource agency responsible for water, energy, and environmental resources in the Kings River region. Activities include:

Flood Control Responsible for maintaining more than 170 miles of flood control levees on the Kings River.


**Hydroelectric Generation** Owner/operator since 1984 of the Pine Flat Power Plant, providing reliable, low-cost power to the State Water Project pumping facilities.

**SGMA** Supporting implementation of SGMA for the Kings and Tulare Lake Subbasins. KRCD provides staff support to six of the 12 GSAS in the service area.

Water Quality Leading implementation of the Irrigated Lands Regulatory Program and CV-SALTS in the region.

**IRMWP** Managing and participating in the Kings Basin Water Authority, the governing body implementing the Kings Basin Integrated Regional Water Management Plan for the Kings Subbasin.

**Fisheries** A party to the Kings River Fishery Management Program, providing financial, biological, engineering, and project construction support to enhance the fishery of the Kings River below Pine Flat Dam.



# **Regulatory & Other Impacts Affecting Farmers**

Farmers abilities to continue farming is increasingly threatened due to the variety of pressures on their operations. Regulations and other impacts effect their ability to feasibly and economically farm. Impacts to farmers have a ripple effect in the ag-based economy of the Kings River service area. Below are just some of the issues that challenge growers and their ability to compete in national and international markets. Their concern is the ongoing layering of new laws and regulations. The daily challenges continue to become more compounded.

## Water Regulations



Water regulations imposed on growers greatly increase farming operations costs. These include, new and changing reporting requirements, new agencies to interact with, additional fees, and time constraints to name a few.

Some Irrigated Lands Regulatory Program requirements include:

- Keeping irrigation water from flowing off farms and into rivers and streams
- Tracking and reporting total nitrogen applied
- Preparing and implementing a "certified" Nitrogen Management Plan for every crop
- Testing drinking water and providing notice to consumer and regional board
- Paying fees to the State Board and to their local Coalition
- Attending mandatory outreach events

It is estimated that the Sustainable Groundwater Management Act will remove over million acres out of production. The administration of CV-SALTS will come with enforcement actions to provide drinking water to consumers who live on ag lands.

Drought Resiliency and Water Supply Infrastructure Act

Bill Summary: Last edited by TFG Reports at Jan 16, 2020, 10:27 PM This bill would support water infrastructure in the nation's Reclamation states, as well as extend federal funding an additional five years, including \$670 million in surface and groundwater storage projects; \$100 million for water recycling projects; and \$60 million for desalination projects. The bill would also establish a new loan program for water agencies designed to spur investment in new water supply projects. Key provisions include but are not limited to expanding and updating the Bureau of Reclamation funding authorizations in the Water Infrastructure Improvements for the Nation Act (WIIN) to fund portions of federal (50%) and non-federal (25%) surface and groundwater storage and conveyance facilities, as well as cost share (25%) additional water reuse and recycling and desalination projects; and creating a new loan program at 30-year Treasury rates for water supply projects under what would be established under the Reclamation Infrastructure Financing and Innovation Act (RIFIA). These loans would use criteria (49% maximum loan) modeled after the well-established Water Infrastructure Financing Innovation Act (WIFIA) program at the Environmental Protection Agency (EPA). The legislation would also authorize \$140 million for restoration and environmental compliance projects, including forest, meadow and watershed restoration projects with water benefits and projects to help restore threatened and endangered species affected by Reclamation water projects.

Dear Secretary Mnuchin and Chairman Powell,

We write to urge the Treasury Department and the Federal Reserve to expand access to the Municipal Liquidity Facility to special districts that provide essential services such as drinking water, wastewater treatment, and fire and police protection.

Special districts are suffering severe revenues losses and increased costs from COVID-19, just like other units of local government and states. The COVID-19 financial impact this year on water and wastewater districts alone is estimated to be \$30.7 billion (\$13.9 billion for drinking water utilities projected by the American Water Works Association, and \$16.8 billion for wastewater utilities projected by the National Association of Clean Water Agencies).

We appreciate the June 3 changes to the Municipal Liquidity Facility's term sheet that will allow governors to designate up to two Revenue Bond Issuers per state that can receive access to the facility. However, this access will not go far in California, which has 1,913 special districts. Rather than limiting the total number of eligible facilities, we ask that you rely instead on the term sheet's independent provisions requiring a minimum credit rating for public entities to access the Municipal Liquidity Facility.

Given that only public entities with solid credit are eligible, we urge you to consider opening the facility to any special district that meets those credit eligibility standards. These districts need assistance to continue to provide essential public services through the pandemic, as described in the attachment. Thank you for your consideration of our request.

# Attachment: Examples of the Effect of COVID-19 on Special Districts

## Southern Cascades Community Services District

Southern Cascades Community Services District provides emergency medical services, specifically emergency medical transport to southern Modoc and northern Lassen County. The district also provides non-emergency medical transport services to Lassen, Modoc, Shasta and Siskiyou counties. The district operates a medical helicopter base, medical helicopter and a training facility.

According to Dan Bouse, General Manager: "Our district has suffered revenue losses over the last two months approaching \$100,000. We are now drawing down our unrestricted reserves to make payroll. Non-essential staffing has been furloughed and the level of EMS Services have been decreased. In addition, we continue to experience shortages of Personal Protective Equipment which has forced us to use alternatives and search out more expensive sources to meet minimum safety requirements. In addition, we have had to supply patients with masks, safety wipes, etc. before they can be seen in a medical facility as they are unable to procure them."

# **Del Puerto Health Care District**

Del Puerto Health Care District provides healthcare and emergency medical services to 30,000 residents in rural northwest Stanislaus County. On April 3, the district wrote:

COVID-19 has brought significant challenges to our community and our district. As a Rural Health Clinic and Emergency Medical Services (EMS) provider we are on the front lines of the Coronavirus pandemic. Our patient visit count at the Clinic have dropped by 50% with a large portion of the remaining visits often being conducted by telemedicine. Our ambulance service has the same number of transports to the hospital; we are conscientiously ramping up staffing to serve the foretold surge. Our income is predicted to be down by 40-50% this year. We are a fortunate operation with 90 days of operating cash in reserve, but are wrestling with the decision to layoff half of our clinic staff for the preservation of that reserve. I would much rather keep them fully employed."

# **Oxnard Harbor District – Port of Hueneme**

Oxnard Harbor District – Port of Hueneme imports and exports essential cargo, including produce and automobiles, to residents in Ventura County and 15 surrounding states. The district serves over \$9 billion in cargo activity that generates over \$1.5 billion in economic impact and \$119 million in taxes annually, supporting more than 15,834 direct, indirect, induced and influenced jobs regionally. The district writes that it:

Receives no tax-related revenues and anticipates \$7.1 million in COVID-19 response expenses and losses in revenue through 2021 fiscal year; experiencing a 30 percent revenue loss in 2020 due primarily to decline of auto industry sales related to the pandemic. In confronting COVID-19, the district is providing personal protective equipment, disinfectants, and additional precautions to waterfront workers as they move cargo. The district also is supporting the hardest hit communities in the region through providing meals to farmworkers, lunches to longshoremen supporting the local restaurants, and a blood drive.

# **Vista Irrigation District**

Vista Irrigation District provides water service to more than 136,000 people in the City of Vista, portions of San Marcos, Escondido, Oceanside and some unincorporated areas of San Diego County.

According to Brett Hodgkiss, General Manager: As of May 27, "Vista Irrigation District has a \$50,000 revenue shortfall for non-payment of water bills as well as \$15,000 in direct COVID-19 related expenses. Vista Irrigation District expects a revenue shortfall of up to \$1.57 million in the coming fiscal year as a result of customer non-payments, lower interest earnings and reduction in developer fee related revenue as well as an additional \$12,000 in direct COVID-19 related expenses."

## **Cosumnes Community Services District**

Cosumnes CSD provides fire protection and parks/rec services to 205,000 residents in Elk Grove, Galt and southern Sacramento County.

According to Joshua Green, General Manager: "As a provider of Fire and Emergency Medical Services, we have continued to serve the community and continue to incur additional costs for PPE and other essential equipment. As a provider of Parks and Recreation services, we closed all of our community sites, all recreation activities and programs, events and rentals were suspended or cancelled; all picnic areas, playgrounds and sports courts were closed as well. For every month that these resources are closed, and events suspended the District suffers a revenue loss of \$800,000, while continuing to have outgoing cashflow for fixed cost items. When the COVID-19 situation begins to subside, this revenue loss (in large part due to the seasonality of revenue generating programs) will significantly impact the District throughout the next fiscal year of recovery."

## Midpeninsula Regional Open Space District (Midpen)

Midpen oversees the management of 65,000 of protected open space on the San Francisco Peninsula, and serves 770,000 constituents. The district acquires and preserves a regional greenbelt of open space land in perpetuity, protects and restores the natural environment, and provides opportunities for ecologically sensitive public enjoyment and education.

According to Ana Ruiz, General Manager: "At this time, Midpen estimates a \$1.5 million revenue loss for FY 20/21 and have spent approximately \$400,000 retaining field staff through shelter-in-place and unanticipated expenses as a result of the pandemic. Planned hiring has largely been frozen, while critical wildfire fuel reduction work has significantly slowed. This is happening at a time when the public increasingly relies on outdoor agencies like ours to offer health and respite opportunities as part of their shelter-in-place orders."

#### RE: ACWA Request for Water Infrastructure Funding in Future COVID-19 Legislation

Dear Majority Leader McConnell, Minority Leader Schumer, Speaker Pelosi and Minority Leader McCarthy:

The Association of California Water Agencies (ACWA) appreciates your leadership to address the disastrous consequences caused by the recent COVID-19 outbreak by passing legislation to provide relief for this emergency. As you consider further measures to help our country recover economically - including boosting federal funding for infrastructure –ACWA respectfully requests you include water infrastructure funding in future COVID-19 legislation to help provide jobs and address the shortcomings of both California's and the West's aging water infrastructure. ACWA's 455 public water agency members supply over 90 percent of the water delivered in California for residential, agricultural, and municipal uses.

#### **DETERIORATING FINANCIAL CONDITIONS**

Even before the COVID-19 crisis, California's water community, along with much of the nation, faced deteriorating infrastructure, increased regulatory compliance costs, climate related challenges, and population growth. A recent study by the American Water Works Association (AWWA) and the Association of Metropolitan Water Agencies (AMWA) indicates water providers are facing increasing financial difficulties due to the COVID-19 pandemic.

The study states:

The results of the assessment indicate that the aggregate financial impact of COVID-19 on drinking water agencies will likely be approximately \$13.9 billion, representing an overall 16.9 percent financial impact on the drinking water sector. These impacts are a result of drinking water providers eliminating shut offs for non-payment, anticipated increased delinquencies as a result of high unemployment rates, reductions in nonresidential water demands and associated revenues offset by increases in residential consumption, and lower customer growth.

Due to these financial impacts, drinking water agencies across the nation are anticipated to delay and reduce capital expenditures by as much as \$5 billion (annualized) to help



manage cash flows due to the crisis. These capital expenditure reductions will have a cascade effect on economic activity in communities across the U.S. As a result, communities will experience a reduction in economic activity by as much as \$32.7 billion (annualized) in aggregate when considering economic multiplier effects. The reduction in capital expenditures is also anticipated to result in a loss of 75,000 to 90,000 private sector jobs.

The financial impact of the COVID-19 crisis on water and wastewater agencies combined is estimated to exceed \$27 billion.  $^1$ 

#### AGING INFRASTRUCTURE CONCERNS

The Bureau of Reclamation (Reclamation) delivers water to 31 million Americans throughout the west and supports \$63.9 billion in economic output and 456,000 jobs. First established in 1902, Reclamation operates over 500 sites including dams, reservoirs, canals, and hydropower. Many of Reclamation's facilities are between 50 and 100 years old and in serious need of repair. Additionally, Reclamation currently is experiencing an infrastructure and maintenance backlog of approximately \$3 billion. \$700 million of the backlog is for Title XVI recycling projects.

ACWA strongly encourages Congress to include a Reclamation Title in any future COVID-19 infrastructure legislation to provide jobs, address aging infrastructure and related water supply concerns now facing the Bureau of Reclamation.

#### **COMPREHENSIVE APPROACH**

ACWA believes that water use efficiency, water recycling, desalination, wildfire management/headwaters protection, safe drinking and clean water, ecosystem restoration, regional and inter-regional water resilience, groundwater, flood protection, and surface storage projects are all needed for a diversified, jobs producing water management portfolio and such efforts must be included in future COVID-19 stimulus packages. Types of projects that should be included are:

**Dam Safety/Reservoir Operations:** Dam safety projects at high hazard dams, reservoir seismic retrofit projects, and new spillways and repairs at existing dams to facilitate implementation of Forecast Informed Reservoir Operations.

**Regional and Inter-Regional Water Resilience**: Regional and inter-regional water resilience projects, including regional water conveyance projects and water quality projects.

**Groundwater**: Projects that support groundwater banking, conjunctive use, water quality monitoring and remediation, including for contaminants of emerging concern, or other groundwater projects and programs that improve water resilience and reduce groundwater overdraft.

**Flood Protection:** Flood infrastructure projects to support flood risk reduction and provide State cost shares for priority U.S. Army Corps of Engineers projects. Multi-benefit flood control projects that support multi-benefit flood risk reduction and ecosystem restoration efforts.

**Storage:** New water storage projects, traditional construction or green infrastructure, tailored to local circumstances and need, to help adapt to a changing hydrology and develop usable and sustainable supplies to meet growing demands for water.

**Water Recycling, Desalination:** New water recycling and brackish and seawater desalination projects currently being studied or that are ready for construction.

**Safe Drinking and Clean Water**: Projects to help provide clean, safe and reliable drinking water to all Californians and the nation.

**Ecosystem Restoration:** Ready-to-go projects for water management improvements, fish passage, and habitat restoration - all in support of water project operations in the Reclamation states of the West.

**Water Use Efficiency:** One of the most cost-effective actions that can positively affect water supply stability.

**Wildfire Management/Headwaters Protection:** 1) It is imperative for Congress to consider our country's readiness to fight wildfires in the COVID-19 context and ensure sufficient resources are available as the wildfire season begins, especially in the West. 2) Restoration, construction and maintenance work are needed within our federal forests, whether to improve roads, protect headwaters, reduce wildfire risk or increase the ability of our forests to capture and store carbon. There are approximately 80 million acres of national forest lands in need of restoration, including wildfire risk reduction, and many projects are already "NEPA-ready." Hazardous fuels reduction work often relies on contractors and is labor intensive but has many co-benefits to improve forest health while protecting communities from catastrophic fires.

#### **FUNDING MECHANISMS**

#### **Environmental Protection Agency**

**State Revolving Funds:** ACWA supports strong funding levels for the State Revolving Fund (SRF) programs. ACWA believes the SRF sustains a robust water infrastructure funding partnership between the federal government and local communities to protect the integrity of our headwaters, deliver safe and reliable drinking water and enhance our ecosystems. From its inception, the SRF has proven to be an effective and efficient means to help meet the significant needs of local communities.

In California, the SRF programs provide vital support for a variety of water infrastructure needs. ACWA's members have used the programs to support core water quality treatment functions, develop recycled water capacity, build resilient water supplies and capture sustainable energy from the treatment process. During the recent several years of extraordinary drought conditions, the SRF programs served as a lifeline to construct water recycling facilities and other critical infrastructure. Without these funds, the impact of the drought would have been significantly more severe.

**Water Infrastructure Finance and Innovation Act (WIFIA):** ACWA supports increased funding for the WIFIA program. ACWA's members are pleased to be utilizing this new water infrastructure financing tool. With its focus on large projects, ACWA believes that WIFIA complements the SRF programs. ACWA also encourages Congress to consider steps to make WIFIA even more attractive to borrowers, including extending repayment terms from 35 to 50 years.



#### **Department of Interior**

**Bureau of Reclamation:** ACWA recognizes Congress has recently provided Reclamation with important funding increases over a five year period. ACWA supports increasing Reclamation's budget above the FY 2020 enacted level of \$1.66 billion. This includes at least the \$137 million provided for all WaterSMART projects, including Title XVI water recycling program and WIIN recycling, and WaterSMART Grants. Significant funding should also be provided to support the WIIN Desalination Program, WIIN Storage Program, and WIIN Operational Review and listed species monitoring. ACWA supports additional funding to assist Reclamation's transferred works operators in financing through P.L. 111-11 repayment contracts extraordinary maintenance and replacement projects on federally owned water delivery and management infrastructure. ACWA also supports efforts to create a new WIFIA-like financing program within Reclamation, which would provide low-cost, long-term financing support for non-Federal water supply and water management projects.

**Wildland Fire Management:** The Department of the Interior is responsible for risk reduction on the more than 420 million acres it manages and another 55 million acres of tribal lands held under trust. Like the Forest Service, investments focused on highest-priority fuels management would result in boots on the ground, restored landscapes and safer communities and water supplies. For California, doing so is critical to safeguarding our nation's most iconic species (e.g. giant sequoia) and landscapes like the Sierra Nevada.

#### **Army Corps of Engineers**

ACWA supports increasing the Army Corps' budget above the \$7.65 billion Congress provided in FY2020. ACWA also supports funding for USACE's implementation of the Water Infrastructure Finance and Innovation Act (WIFIA) to support expanded investments in non-Federal flood control works, including levees and dam safety projects, and ecosystem restoration projects. Additionally, ACWA supports increased funding for flood risk reduction projects, O&M, environmental infrastructure, and construction accounts.

## **Department of Agriculture**

ACWA encourages Congress to provide strong funding to fight catastrophic wildfires. ACWA supports increases to the Collaborative Forest Landscape Restoration Program; Watershed and Flood Prevention; Watershed Rehabilitation Program; Capital Improvement and Maintenance; forest restoration, including wildfire risk reduction; and Water Source Protection Program.

States have invested much time in their state forest action plans (SFAPs). Grant funding for states would help to prioritize SFAPs that focus on fuels reduction, forest health, urban trees and other projects. This infusion of funding would primarily support rural jobs but also urban jobs.

The Collaborative Forest Landscape Restoration Program (CFLRP) has a proven track record in improving forest health, mitigating wildfires, and supporting rural economies.

ACWA also encourages continued coordination between the USDA Natural Resource Conservation Service (NRCS) and Reclamation in funding both on-farm and on-ditch water management improvements to benefit water supplies, water quality and the environment.



#### Department of Homeland Security

**Federal Emergency Management Agency (FEMA):** ACWA supports increasing funding to the Rehabilitation of High Hazard Potential Dam Grant Program and the Building Resilient Infrastructure and Communities program (BRIC).

#### **Expedited Measures**

In the past, Congress has, on a bipartisan basis, put forward significant efforts to streamline and improve environmental regulation and permitting processes. Any infrastructure package should contain similar provisions to streamline the development of water projects.

# KRCD Communications Campaign

**Recharge Campaign Story Map:** External Affairs staff used research and materials gathered to begin developing a story map outline, identifying key locations. Staff will continue to develop the outline and identify assets such as facts, figures, images, video, and interviews needed to put a story map together. The outline tells the story of the Kings River watershed and the ultimate need for increased capacity on the system to meet the dichotomous needs of demand and sustainability. Stops along the story map include diverse projects that highlight the existing infrastructure, while also pinpointing needed projects that will require capital investment. External Affairs staff began using the coordinated information collection from Water Resources staff to identify potential data visualization to include in the story map.

**E-Updates:** External Affairs staff uploaded past SGMA E-News email updates to the KRCD website "stories" page for public reference. Staff attended regional SGMA meetings to compile status updates for the next SGMA E-News update to release the first week of July. Staff also coordinated across departments to increase efficiency on meeting attendance, exchanging notes from Water Resources staff attending on Water Resource Department's behalf.

**Social Media Campaign**: External Affairs staff members began a social media campaign to promote the irrigation season in the Kings River region. The objective is to highlight the value of Kings River as a local source of water. The campaign included several Tweets and Facebook posts covering the topics of agricultural use, urban use, irrigation and canals, and local management of the Kings River. This included highlighting irrigated agriculture with features of fresh farmers market finds, municipal water use at the southeast Fresno surface water treatment plant, and the conveyance of river channels and canals. Multi-media assets accompanied tweets and Facebook posts.

**Social Media Platform Publisher:** External Affairs staff began using a social media management tool, Hootsuite, to schedule and manage monthly post calendars and gather analytics for the 8 social media platforms managed by staff. The new tool helps ensure continuous content flow across social channels for each agency, and aids in higher efficiency with staff resources and measuring outcomes.

**External Communications Policy**: External Affairs staff drafted an External Communications Policy. KRCD's External Communications Policy discusses process and


protocols for external speaking engagements. Once the policy is reviewed by senior management, it will be presented to the Board for consideration to adopt.

**Human Resources:** External Affairs staff assisted in the formatting and dissemination via website and social media channels of the hiring brochure for the open Controller position.

**Water Safety Council:** External Affairs staff assisted the Water Safety Council with its monthly Facebook advertisement run. A graphic with a photo background of a pool included messaging urging the public to ensure an adult is always supervising children around a pool. A single ad promoting this messaging was run for a total of \$100. The post reached 10,708 individual people and received 811 engagements, including 192 post shares.


## Social Media Monthly Analytics



## WATER QUALITY <u>Kings River Water Quality Coalition (KRWQC or Coalition)</u>

#### KRWQC Board Meeting

The KRWQC Board met remotely on June 16<sup>th</sup>. Items discussed were the status of 2019 Payments and Reporting, Fill Station updates, Management Zone development, and Approval of the 2020-2021 Budget. The Board also received a report from Brad Esser from Lawrence Livermore National Laboratory on Phase II of the Isotope study. A general discussion of the findings for anthropogenic constituents in groundwater (from septic systems) was held. The Nitrate data collected between Phase I and Phase II was highly correlated. Human-sourced constituents were inconclusive, due to detections below the Reporting Limit.

Fill Station Development and Construction



The Hanford fill station was closed temporarily June  $5^{th} - 9^{th}$  for extensive cleaning and maintenance of the sediment filter. Staff are implementing an updated maintenance schedule to correct the issues. Sampling, cleaning, and maintenance frequency have been increased.

On June 12<sup>th</sup>, comments were received from the City of Kerman on the Kerman fill station permit. The City requested additional construction details for the shade structure, accessibility (ADA) requirements, electrical conduit, and pipeline materials. Resubmittal will be completed in early July with the requested details. Construction and fill station delivery is anticipated end of July. 58 Coalition staff and consultants have been working with Tulare County to finalize a site plan and agreement for the Dinuba fill station located at the Dinuba Public Library. A legal description from the preliminary design (rendering) of the site was submitted on June 24<sup>th</sup> for incorporation into the fill station agreement. The Coalition continues to work through necessary insurance requirements.

#### Nitrate Management Zones

KRWQC policy committee and board has determined to use the Coalition boundary as the Kings Nitrate Management Zone for the Preliminary Management Zone Proposal due to the Regional Water Quality Control Board on March 8, 2021. In addition, the Management Zone participants will need to develop an Early Action Plan that will provide short-term water supply solutions to areas with nitrate impacted wells. The Coalition held a Management Zone informational workshop on July 28, 2020 at 10:00 a.m. for all discharges and interested parties in the priority one areas.

#### <u>Isotope Study – Phase 2</u>

Results of the Phase II study were presented at the KRWQC Board Meeting on June 16<sup>th</sup>. A final publication of the results is pending.

#### KRWQC Membership Activities

As of June 25, 2020, 3,847 members have submitted payments totaling in \$2,365,111 covering approximately 749,890 acres. A final invoice will be sent in July to all members who not yet made a payment and to any member with a balance on their account of ten dollars or more.

Members continue to submit reports using hard copy templates, KRWQC online reporting database, or by utilizing a third party. Membership use of the online reporting database continues to increase with a total of 1,812 members reporting online as of June 25<sup>th</sup>.

Of the 3,486 members required to submit a Farm Evaluation and Nitrogen Management Plan Summary Report this year, 118 Farm Evaluations have been submitted this month totaling in 3,229 and 159 Nitrogen Management Plan Summary Reports submitted this month totaling 3,193 for the 2019 crop year.

A fourth reminder notice was mailed the beginning of June to 464 members who have not yet submitted the Farm Evaluation and/or Nitrogen Management Plan Summary Report. In addition, KRWQC staff continue to reach out by phone to those members whose report(s) were not received by the end of April.

#### Web-Based Submittal Database

The Coalition board approved a new web-based portal will be launched during the next reporting round with the new reporting requirements.

#### **Outreach Activities**

The Coalition continues to send postcards to members who have yet to submit a Farm Evaluation or Nitrogen Management Plan Summary to remind them of the March 1<sup>st</sup> reporting deadline. In addition, a robust outreach program is being developed for the new Management Zone.

#### Surface Water Quality Monitoring Plan Revisions

The consultant continues to prepare the updates to the Surface Water Monitoring Plan. Additional Work is underway to select the pesticides that will be monitored during the 2020 sampling year. The proposal will specify that these parameters will be tested for limited David M. Merritt, Deputy General Manager, Chief Operating Officer July 7, 2020 Page 4

sites during 2020. A meeting to discuss the Surface Water Monitoring Plan revisions is scheduled for January 17, 2020.

#### Surface Water Quality Sampling Activities

Surface water samples were collected from Gould Canal, Manning Ave, Lemoore Weir, Jackson Avenue, and Empire Weir 2 on June 15, 2020. Field sheets and photo documentation were collected at all sites.

#### **Drain Survey Activities**

The monthly drain survey was conducted on June 30, 2020, for the upper river from Army Corp Bridge to Hwy 41. A portion of the south fork drains were also completed on June 30, 2020. All remaining drains were assessed on July 1, 2020.

#### Groundwater Quality Trend Monitoring Plan

The Coalition continues to work with subconsultants on the reevaluation of current rationale for the representative groundwater quality trend monitoring (GQTM) network. The Coalition anticipates a meeting with the Regional Board in August to continue discussions on the updated methodology.

#### Groundwater Quality Trend Monitoring Activities

Groundwater Quality Trend Monitoring was completed in June for 2020. Follow-ups will be completed in July for unresponsiveness or wells temporarily out of service.

#### Comprehensive Groundwater Quality Management Plan

The Management Practices Implementation Report (MPIR) was presented to the Regional Board staff on June 25<sup>th</sup>. Once the formal proposal is submitted, it is anticipated that it will be made available for a forty-five-day public comment period. The proposal is to present a limited MPIR to the Board now, and when certain revisions to the Comprehensive Groundwater Management Plans are made later this year, a revised MPIR will also be submitted. This allows the coalitions to provide synthesized data from the FE reports in 2021 (covering the 2020 crop year) and add additional elements as the requirements are adjusted later.

## <u>Southern San Joaquin Valley Management Practices Evaluation Program (MPEP)</u> <u>Committee</u>

The MPEP/CVSALTS committee met remotely on June 3, 2020. Consultants discussed the submittal of a CIG grant application due to NRCS on June 29, 2020. In addition, a FREP application was made in mid-May to analyze additional small acreage crops. The Barriers to Adoption study being conducted by UC Davis is underway. This study is a random survey of coalition members asking questions related to management practices in use and the decision process growers use when making changes. The results of this study can inform the coalition as to the outreach efforts required should management practice changes be mandated. The Northern coalitions indicated that they are holding a workshop for the environmental justice community at the request of the Regional Board which will discuss the MPEP efforts and Soil Water Assessment Tool (SWAT model). Finally, the committee discussed the State Water Board Surface Water Expert Panel meeting which will be held in August, so as to allow an "in-person" discussion.

# KRWQC/KRCD serves as the Fiscal Agent for this Committee. (Participants: Kings, Kaweah, Tule, Kern, Cawelo, Westside, Buena Vista Coalitions).

## <u>Central Valley Salinity Alternatives for Long-Term Sustainability (CV-SALTS)</u>

The CV-SALTS Executive Committee met virtually on June 18, 2020. The Executive Committee discussed the implementation of the adopted basin plan amendments including notices to comply for the nitrates and salinity, Management Zone status updates, Prioritization & Optimization Study Salinity targets, and outreach efforts. The Regional Water Quality Control Board mailed Notice to Comply letters on May 29, 2020 and the Coalition has been steadily receiving inquiries about the program. The Coalition is hosting a Nitrate Control Program workshop on July 28, 2020 for dischargers in the region.

KRWQC/KRCD is the fiscal agent for this group. (Participants: Kings, Kaweah, Tule, Kern)

## Central Valley Groundwater Monitoring Collaborative (CVGMC)

The QAPP for the CVGMC has been approved and the document signed by all parties. A revised workplan has been prepared and accepted by Regional Board staff.

KRWQC/KRCD is the fiscal agent for this group. (Participants: Cawelo, Buena Vista, East San Joaquin, Kern, Kings, Kaweah, Kern, Westside, Westlands)

## Regional Water Quality Control Board (RWQCB) Activities

Regional Board staff have not taken any enforcement actions during the month of June 2020. This is likely due to continued reduced Board staffing.

## North Fork Kings GSP Activities

The North Fork Kings GSA board created a standing Policy committee to develop and discuss policies related to the implementation of the GSP. The Board also heard a summary of the Kings subbasin annual report for the consultant; information regarding the annual report can be found on the North Fork Kings GSA website.

DWR found a clerical error in the amended Prop 1 Round 3 grant agreement that excluded language for the eligible cost dates, which must be added back into the agreement. Staff are awaiting an amendment form from DWR to sign and execute the minor change.

#### South Fork Kings GSP Activities

The South Fork Kings GSA participated in the Virtual Launch for the California Resilience Challenge.

DWR concluded the public comment period for the subbasin GSP on May 15, 2020. The Tulare Lake GSP received 13 comment letters that are currently being reviewed.

At the June 17, 2020 Advisory Committee meeting, the Committee received staff reports, approved a recommendation the Board to consider XiO, Inc. as an Interested Party and approved a recommendation to the Board to consider eight new projects to the IRWMP project list. The Outreach Committee held a meeting on June 24, 2020 to review and discuss updates made to the KBWA highlight brochure. Staff continue to work with P&P on updates to the brochure.

## Prop 1 Disadvantaged Communities (DACs) Involvement Grant

The Project Advisory Committee (PAC) met on June 18, 2020 via Zoom teleconference. The PAC approved the deliverables completed to date by Self-Help Enterprises (i.e. white area recommendations sheet, community needs assessment survey results summary, and DAC engagement and outreach recommendations sheet). Self-Help Enterprises (SHE) is also working to develop an IRWM educational video, for which SHE interviewed KRCD staff member Soua Lee about the IRWM Program on July 1<sup>st</sup>. The PAC also approved the Needs Assessment Report prepared by P&P but allowed for any additional comments on the report to be submitted by July 10, 2020.

## Prop 1, Round 1 IRWM Implementation Grant

Prop 1 Round 1 IRWM Implementation Grant Program awarded the Fresno Metropolitan Flood Control District \$1,113,033 for their Basin "CF" Groundwater Recharge and Flood Protection Project. This project would provide a direct benefit to the community of Malaga. Staff received the DWR Award Letter and submitted a response accepting the award on June 9, 2020. Staff are working with FMFCD to submit any updates to the work plan, budget and schedule for the grant agreement.

## Inter-regional and Statewide Coordination

Staff participated in a bi-monthly meeting of the Tulare Basin Regional IRWM Coordination Group on June 1, 2020 to share and discuss updates to the IRWM Program. The meeting included discussion on any upcoming grant opportunities for IRWM type projects, the status of the current Prop 1 IRWM Implementation grant and DAC Involvement Program, and activities related to SGMA implementation within the Tulare-Kern Funding Area.

## **Reservoir Status:**

The reservoir elevation began the month at 919.16 feet (ft.) and storage of 819,322 acre-feet (AF). As of July 1, 2020, the reservoir elevation was 883.03 ft. and storage of 640,410 AF. Turbine discharge for the month was 285,622 AF. Discharge through the turbine bypass system was zero AF. Spill from the dam for the month was zero AF. Flow from Mill and Hughes Creeks was 42 AF.

Power Market Price Shaping – I have been discussing with CDWR the potential opportunity to price shape the output from Pine Flat due to negative market prices because of increased renewable integration (solar). Model development is underway – future conversations will continue.

Completed an annual report covering the facility operations and maintenance and a high-level discussion on major contracts and licenses for the 2019 calendar year (attached). We will develop this on a routine basis going forward.

#### **Operations & Maintenance:**

- Routine monthly preventative maintenance tasks completed.
- Gathered readings on newly installed microprocessor relays for setup of the third harmonic ground trip for each generator. This required each generator to be at maximum output.
- Provided PG&E running data from newly installed microprocessor relays for review and final approval of upgrade.
- Developed NERC training modules for plant staff based on newly installed protective relays
- Performed infrared survey of plant electrical equipment.
- Pulled oil samples on all transformers and the oil filled circuit breaker for analysis
- Replaced the carbon brush air filters on all three generators
- Filtered and pulled samples from Unit 3 bearing oil tubs.
- Pulled plant drainage pump no. 2 for overhaul and repair. This is original plant equipment and first major repair of this equipment.
- Assembled and installed a new ADA accessible picnic table at the FERC fishing access site. Prior table was vandalized and damaged by a large fallen tree branch.

## Environmental, Health and Safety (EH&S):

Facility safety record as of July 1, 2020 - 887 days without a lost-time incident.

Quarterly plant safety inspections were completed. Monthly safety meetings covered hand safety and COVID-19 related items.

Zurich Insurance (Boiler and Machine) reached out with a data request for this year's survey. Due to COVID-19, the inspection will be performed remote based on data / records provided to them.

McMillen Jacobs provided their DRAFT feasibility assessment report, I have provided several suggested changes. Based on their findings (positive), we plan to develop a Request for Information (RFI) to go out to potential turbine suppliers to firm up the configuration, cost and performance guarantees needed.

## Water Storage Opportunity Projects:

Stantec was provided the go ahead on further evaluating the project considering SGMA potential projects. We hope to have a DRAFT sometime in August and will review with the water users.

## ENVIRONMENTAL DIVISON

#### **Administrative Items:**

All environmental staff continue remote work due to COVID-19 requirements.

The Executive Director of the Kings River Conservancy reached out to me concerning a public access project the USACE is proposing just downstream of the USACE Bridge (left bank) and to discuss the overall fishery on the Lower Kings.



# **2019 Annual Report**

# **Executive Summary:**

The Jeff L. Taylor Pine Flat Power Plant started commercial operation April 1984. The facility operates under a 50-year FERC license number 2741, set to expire September 2029 and a long-term Power Purchase Agreement (PPA) with the California Department of Water Resources for 50 years. The PPA includes contract extensions beyond the initial term for construction cost overrun and guaranteed annual energy delivery. Other pertinent agreements are with the United States Army Corp of Engineers for use of Pine Flat Dam and the Kings River Water Association for use of Kings River water.

The power plant started annual operation March 7, 2019 and remained in service through November 1, 2019. The annual capacity factor was 49.4%, the annual historical average is 28.1%. The facility generated 719,960 Gross Mega Watt hours (MWhrs) with a net delivery of 714,557.9 MWhrs. Gross revenue was \$5,430,640, and a resulting net revenue to KRCD of \$2,715,320.

The annual maintenance outage started on November 1, 2019 and continued into 2020. Major work during this outage cycle involved upgrading all generator and high voltage equipment yard relay protection from electromechanical to microprocessor relays.

There were no recordable or lost time injuries over this period and all regulatory compliance maintained. The facility continues to hold routine safety meetings, complies with regulatory training requirements, and utilize an outside safety consultant to perform annual inspections of the facility to ensure OSHA / Cal OSHA compliance.

# License for Diversion and Use of Water- Annual Usage:

The License for Diversion and Use of Water allows for a max annual usage of 2,732,000 acrefeet and a maximum 14-day average flow rate of 7,900 cubic feet per second. The annual usage is reported to the State Water Resource Control Board and annual fees paid. KRCD will be required to provide real time reporting of our diversion onto a public access website in 2020. We plan to create a link on the existing KRCD webpage to meet this requirement.

# **Operational Events:**

#### Forced Outage Event Summary:

- April 2, 2019 Unit 1 and 3 tripped at 1640 hours and back online at 2005 and 2006 hours respectfully. This issued was caused by a lightning strike in zone 2 with resulting PF-762 (230 kV line breaker) tripping open. No other issues found, and units started without issues.
- 2. May 9, 2019 Unit 1, 2, and 3 tripped at 1453 hours and back online at 1459, 1502 and 1504 hours respectfully. This tripped was caused by technician working on the B phase transformer high oil temperature gauge. A review of work performed / cause of trip was discussed with plant staff to avoid future issues. New gauges were ordered and replaced on all three transformers during the annual maintenance outage.

- August 26, 2019 Unit 2 tripped at 0908 hours and was placed back online at 1446 hours. The unit tripped on vibration. Staff troubleshot all instrumentation and the turbine mechanically with no issues found. Unit restarted without issues.
- 4. October 1, 2019 Unit 3 tripped at 2339 hours due to operator error, inadvertently tripped unit due to moving 26TP gauge needle and making up trip circuit unit was not restarted.

#### **Scheduled Outages:**

- Annual Maintenance Outage Started November 1, 2019 and completed February 14, 2020. During this outage, the major projects completed were:
  - The generator and transformer relays were upgraded from electro-mechanical to microprocessor type relays. HDR performed all engineering studies, Taurus Power & Controls construction of relay panels and commissioning and KRCD staff provided the electrical wiring and installation work of the relay upgrade onsite. All work was reviewed and approved by PG&E for NERC compliance.
  - Transformer winding temperature bulbs and gage replaced on all three transformers.
  - Power factor testing performed on all 3 generators and of Unit 3 generator breaker (PF-324)
  - The river environmental SONDE was upgraded and incorporated into the plant data historian.
  - Routine annual preventive maintenance on generators, turbines, electrical equipment, high voltage yard, and balance of plant equipment.
  - Per NFPA 70E requirements, the facility completed a 10-year update of the arc-flash analysis in 2019 – there were two breakers that required additional changes – these changes were completed during the outage and tested. All required electrical equipment was updated with new arc-flash rating stickers.
  - Oil samples of all three the main transformers and the 220 kV line breaker were pulled in July with acceptable results sample frequency remains annually.
  - Network cyber security enhancements and upgrades completed.
- 2. Unit 1 draft tube inspection September 23 24, 2019. An inspection was performed of the draft tube and penstock coating. All coating was in good condition no repairs were required.
- 3. Unit 2 draft tube inspection and runner inspections performed October 7 24, 2019. Draft tube coating and penstock coating appeared to be in good condition. All runner and wicket gate readings were consistent with prior years readings.
- 4. Unit 3 draft tube inspection September 16 17, 2019. Unit 3 draft tube was recoated 2018 due to failure of coating product used. This inspection was performed within the warranty timeframe of the contract. The inspection showed coating to be in excellent condition.

#### **Operations:**

- Facility P<sub>max</sub> test in coordination with the California Independent System Operator (CAISO) performed on July 2, 2019 for purposes of determining maximum power generation. Pine Flat tested at 198.5 Net MWs. This is above the installed capacity by approximately 17%; however, safely within the operational criteria of the generation equipment.
- Power System Stabilizer (PSS) tuning of all three units to meet compliance with North American Electric Reliability Corporation (NERC) / Western Electric Coordinating Council (WECC) – was performed by Power Tech Labs on the following dates:

# **Safety Training:**

As of December 31, 2019, the facility accomplished 705 days without a lost time injury. The last recordable occurred January 2018 due to a muscle strain while working on electrical equipment. Root cause was due to hyper extending while reaching during maintenance of equipment. The facility

In 2020 we will hire an additional operator in preparation for an anticipated retirement. No additional recruitments are planned within the year; however, succession planning is important to prepare for additional requirements in the next two to five years.

# **Major Contractual & Regulatory Discussion:**

**California Department of Water Resources (DWR)** – the power plant PPA term effectively commenced upon commercial operation of all three generators as described in Section 6.6.7. Unit 3 set the start date of April 1, 1984. The contract initial term is 50 years (March 31, 2034); however, the contract incorporates extensions to the term for the following:

 Construction cost overrun – The projected construction cost for the facility were \$55,000,000 and for every \$5 million in additional cost (fractions excluded), the term would extend for one year. The total project construction cost was \$71,550,964 and amounts to an overage of \$16,550,964. The contract term extends 3 years beyond the initial term to March 31, 2037. The initial term and extension for construction cost were captured in Addendum No. 8 to the Pine Flat Power Sale Contract executed December 19, 2013.

Energy Balancing Account – the PPA ensures DWR 420,000 MWhrs of energy annually. An energy balancing account is utilized per Section 13 of the contract to account for this process. At the end of the term (initial plus construction overrun - March 31, 2037) the positive balance in this account shall be delivered to DWR upon their request – this extension shall not be more than the time needed to deliver the positive balance in the account plus 10 years. As of fiscal year, 2018/19, the extension adds approximately 15 years of time to March 31, 2037

**Federal Energy Regulatory Commission (FERC)** – KRCD received the initial FERC license September 25, 1979. The license has a 50-year term, expiring in 2029. Several activities to prepare KRCD in consultation with DWR have been completed, inclusive of a Strategic Plan (attorney-client work product). Some key dates / activities are:

- 2027 File final license application with FERC
- 2028 NEPA / CWC Section 401 WQC started

Finance staff attended webinars during the month covering topics including employment law, wage and hour law, and COVID-19 updates.






