

SUBJECT: General Manager's Status Report for the Month of October 2020

This memorandum was prepared to supplement the monthly reports of the District's management team and to highlight specific items and activities for the month of October 2020.

State Affairs

Legislative

The 2019-2020 Legislative session will adjourn on November 30th. The Legislature will convene for Organizational Session at 12 PM on December 7th. Both the Senate and the Assembly will swear in their members and, if a quorum is present, may then elect their officers. This will begin the next twoyear session. Although the new session begins in December 2020, it is designated as the 2021-2022 Legislative Session.

Association of California Water Agencies (ACWA) State Legislative Committee (SLC) I attended the ACWA SLC annual planning meeting. Dave Eggerton provided updates associated with the Delta and Voluntary Agreements. Conversations are continuing with Governor Newsom and California Secretary for Natural Resources Wade Crowfoot. Dave mentioned debriefing the ACWA Delta Policy Workgroup in the future. He also mentioned reaching out to ACWA member agencies, and in particular directors, to ascertain what ACWA can do better and where ACWA can add value, as well as engaging with a larger group of members for input.

Cindy Tuck spoke to the Governor's Executive Order pertaining to non-payment of water bills and concerns if an emergency regulation is passed to maintain a requirement for utilities to maintain service to non-paying customers. Cindy also discussed SB 200, focusing on at-risk systems and the lack of a definition of "at-risk," expressing concerns that the definition may be too broad, resulting in funds being spread too thinly.

Two legislative proposals were discussed: one addressing retail water rates validation actions, and another addressing water theft. The validation legislation would expand validation actions to include actions for property-related water, wastewater, and sewer fees and charges. The SLC approved sponsoring the bill. The water theft bill would impose a 10-fold increase in fines to better deter theft. The SLC approved Favoring the proposed legislation.

Public Power shut-offs were also discussed pertaining to generator operations as a means to mitigate shut-off impacts and the on-going effort of using an administrative as opposed to a legislative solution. Moving a Climate Resilience Bond ballot measure forward in 2020 with the Nature Conservancy was also discussed, along with continuing legislative efforts as pertain to Maximum Contamination Limited (MCL) compliance period requirements.

San Joaquin Valley Blueprint (SJVB)

I attended the October SJVB meeting. Scott Hamilton provided a project update focusing on what he described as the most sensible conveyance facilities. He noted the gap between available supplies and

needs south of the San Joaquin River and criticism from the State as pertains to the need for water from the Delta when local supplies have not been leveraged. Austin Ewell and Tommy Esqueda mentioned that the Public Policy Institute of California's San Joaquin Valley Water collaborative actions are in-line with Blueprint goals. They also mentioned ongoing coordination associated with Stanford's outreach and collaborate efforts associated with their Water in the West, Uncommon Dialogue efforts.

A presentation was also provided by Scott Hamilton later in the month as part of the ACWA Region 6 and 7 virtual meeting. Mr. Hamilton focused on average annual water available from the Delta and water needs across the San Joaquin Valley.

Regulatory

State Water Resources Control Board (SWRCB)

In April, Governor Newsom signed an executive order that restricted water shutoffs to homes and small businesses while the State responded to the COVID-19 pandemic. As a result, ratepayer debt has been accruing for months now, leading to revenue losses for water providers across the State. The SWRCB regulates all public water systems in California, serving close to 85% of the State's customers. The SWRCB has not required utilities under its purview to report specific data about how the pandemic has impacted their finances, nor has it tracked ratepayer debt. At its October 6th meeting, the SWRCB announced a new data collection effort to provide some answers to basic questions about how water systems and ratepayers are faring. The SWRCB plans to complete a survey of water systems across California to obtain a sense of the problem's scope.

In other SWRCB news, the SWRCB had ordered a voluntary consolidation order for Orosi Public Utilities District (OPUD) to connect East Orosi to safe drinking water in July 2018, noting that the order would become mandatory if an agreement to consolidate was not reached in early 2019. As a result of little progress toward a voluntary consolidation, the SWRCB has issued a mandatory consolidation order, requiring the two districts to complete the consolidation by the end of 2024. This is the fourth time that the SWRCB has issued a mandatory consolidation since the passage of Senate Bill 88 in 2015, which gave the State authority to order consolidations.

Agricultural Water Management Plans (AWMP)

A draft Guidebook to assist agricultural water suppliers in preparing 2020 AWMPs has been released by the Department of Water Resources (DWR). The Guidebook provides agricultural water suppliers with technical assistance for preparing an AWMP. Agricultural water suppliers providing water to more than 25,000 irrigated acres are required to prepare or update their AWMPs every five years. The 2020 AWMP deadline for adoption is April 1st of 2021. Adopted AWMPs must be submitted electronically to DWR within 30 days of adoption.

California Endangered Species Act

The ACWA Federal Affairs Committee passed along a request from California Forestry Association (CFA) President, Rich Gordon, regarding pending litigation of the United States Fish and Wildlife Service's (USFWS) decision not to list the California Spotted Owl as endangered. There are concerns that California Spotted Owl litigation presents possible impediments to forest management and prevention of catastrophic wildfires, as many forest management projects, both in-progress and planned, already address Spotted Owl habitat. Litigation could affect the ability of those projects to continue or move forward and raise costs. As such, CFA is asking for participation (see attached) in a coalition seeking to intervene in support of USFWS. Although we are in support of the underlying intent, we intend to continue our current regulatory and legislative efforts through our Federal Lobbyists and expand our regulatory and legislative efforts when opportunities arise as pertains to forest management.

Other

ACWA per- and poly-fluoroalkyl substances (PFAS), and 1,2,3-Trichloropropane (TCP) webinar

ACWA hosted a PFAS/TCP webinar to inform members regarding funding avenues to help cover the cost of removing PFAS and TCP. As these constituents are prevalent in much of the Kings, and northern Tulare Lake Subbasins, we are exploring the viability of that funding and how it may be used to help reduce costs associated with Irrigated Land Regulatory Program (ILRP) and Central Valley Salinity Alternatives for Long-Term Sustainability (CV-SALTS) requirements.

California Water Commission (CWC) & Department of Water Resources

The CWC announced four upcoming regional workshops to gather guidance on resilient conveyance priorities, infrastructure, and funding. The workshops will begin an 18-month research and writing project with the goal of providing recommendations to the governor and California Natural Resources Agency (CNRA). DWR will draft the recommendations for CWC approval and transmittal, based on the governor's "30 x 30" Order and Water Resilience Portfolio.

As outlined in the Water Resilience Portfolio, the CWC intends to produce a white paper for State policymakers describing characteristics of resilient water conveyance projects that address a changing climate, outline potential public benefits of such projects, and delineate implications of various financing options. The paper will focus on conveyance other than the pending proposal to improve State Water Project conveyance through the Sacramento-San Joaquin Delta.

CWC staff interviewed stakeholders representing the water industry, agriculture, environmental groups, under-represented communities, academia, and other interests to help frame the discussion as pertains to the role conveyance may play in strengthening the ability of regions to withstand drought, flood, warmer than average temperatures, and changing precipitation patterns.

The CWC intends to continue the conversation by seeking public input through a series of virtual workshops focusing on specific regions of California. Participants from each region will be encouraged to discuss conveyance infrastructure needs, a potential State role in funding such infrastructure, and potential sources of financing.

The CWC will use the information gathered at the regional workshops to help formulate a policy paper with recommendations on the State's role in financing climate-resilient conveyance. The draft paper will be available for public comment before it is finalized and presented to the Administration in mid-2021.

A separate San Joaquin Valley conveyance study is proposed and likely will become a part of this endeavor.

Temperance Flat Reservoir Authority (TFRA)

The TFRA used its quarterly briefing to inform the CWC of its probable dissolution. TFRA Director Aaron Fukuda – Tulare Irrigation District General Manager – updated the CWC on its status. Mr. Fukuda indicated that TFRA lacks sufficient funding commitments to advance toward construction at this time. The TRFA requested the United States Bureau of Reclamation (Bureau) to place the Feasibility Study in a Deferral Status due to lack of a final operation plan. The Bureau is preparing a Deferral Report to establish the current status of the project. The TFRA foresees difficulty in meeting the January 2022 requirements to remain eligible for Water Storage Investment Program (WSIP) funds, which were made available through Proposition 1. TFRA may notify the CWC of an intent to decline WSIP funds. If the funds are returned, the TFRA has requested that the CWC apply returned funds to new projects in the Central Valley that meet WSIP requirements.

Resource Conservation Districts (RCD)

We sent letters (attached) to the Fresno Local Agency Formation Commission (LAFCo) in response to Sierra and Tranquillity RCDs' requests to expand their service areas. We also further explored forming an RCD for which KRCD's Board would be the governing body. The focus of that exploration was the ability to leverage funding that is solely available to RCD's and the ability to leverage the State agency status of RCD's to leverage agency general fund dollars and expedited contracting.

In discussions with Keali'i Bright – Assistant Department of Conservation Director, Land Resource Protection Division – and Jenny Di Stefano – Associate Governmental Program Analyst, Division of Land Resource Protection, and who manages RCD programs within the Department of Conservation – it was determined that there is minimal to no funding remaining that can be solely leveraged by RCD's. They also noted that, although RCD's can leverage State agency status, beyond one exception the only agency that has leveraged this flexibility is the California Department of Forestry and Fire Protection (CalFire), and they do not expect other agencies to engage in this manner. Thus, benefits that may have proved significant, at best appear minimal now.

Nonetheless, a draft outline of legislation has been prepared and will be discussed with our State Lobbyist. Depending upon the outcome of the early November meeting with our Lobbyists and the December Fresno LAFCo meeting, we may or may not move forward with the legislative proposal.

California Water Institute (CWI)

I met with Cordie Qualle – Interim Director of CWI at California State University, Fresno – and Laura Ramos – CALIFT Project Administrator, also representing CWI. We discussed collaboration opportunities between KRCD and CWI and will be having a follow-up meeting with KRCD staff; providing CWI an opportunity to show where they can add value to KRCD efforts, along with discussing and brainstorming ideas. A key aspect of the discussion is how to engage CWI students, with a focus on data.

California Department of Food and Agriculture (CDFA)

I met with Karen Ross, CDFA Secretary. After providing background on KRCD and the various programs and efforts in which KRCD is involved, the focus of the discussion turned to how KRCD and CDFA may be able to collaborate on efforts to reduce impacts and costs to farmers. In particular, the discussion focused on filling data gaps; the first stage of our Multi-Beneficial Water Implementation Study Proposal. Ms. Ross mentioned that the timing of the discussion was excellent, as KRCD's goals align with CDFA priorities and goals, including the Governor's recent Executive Order N-82-20, mentioned in last month's Board report. She believes the State can help in pulling data together and in filling data gaps. She encouraged having something substantive in place in less than a year. Initial plans for a comprehensive meeting to move things forward were discussed with a February timeframe.

Federal Affairs

President Trump signed an Executive Order (EO) entitled "Modernizing America's Water Resource Management and Water Infrastructure." The EO seeks to ensure that Federal agencies work together to more efficiently and effectively improve the country's water resource management; modernize water infrastructure; and prioritize the availability of clean, safe, and reliable water supplies.

The EO formally establishes the Water Subcabinet, a group of senior Federal agency officials, which includes the Department of the Interior, the Environmental Protection Agency, and Departments of Agriculture, Commerce, Energy, and the Army. The EO directs the Water Subcabinet to:

- Identify and provide recommendations to coordinate and consolidate overlapping activities of hundreds of Federal interagency water-related task forces and working groups;
- Develop a national action plan to improve management of our Nation's water resources, and water infrastructure, examining:
 - Water storage and supplies Enhancement, and drought resiliency;

- Water quality Source water protection, nutrient management, and promotion of restoration activities;
- Water systems Including for drinking water, desalination, water reuse, wastewater, flood control, transportation on our rivers and inland waterways; and
- Water forecasting Data management, research, modeling, and forecasting;
- Promote integrated planning among agencies for Federal investments in water-related infrastructure; and
- Support workforce development and efforts to recruit, train, and retain professionals to operate and maintain America's essential drinking water, wastewater, flood control, hydropower, and delivery and storage facilities.

The Water Subcabinet has target dates for providing recommendations on actions and priorities. How the EO will be impacted by a change in the Administration is unknown. If Vice President Biden wins, he may follow the order or choose to modify it with the timeline likely slipping.

Legislative

Bills

Staff are monitoring several bills (see attachment). Below are updates on new bills or bills that have had activity during the month of October:

Corps Bills

Water Resources Development Act (WRDA)

WRDA negotiations continue as a comprehensive water infrastructure bill continues to advance. Staff in both chambers are cooperating on the details of a final package and anticipate the legislation moving to conference and receiving a final vote by the end of the year during the lame duck congressional session.

A final bill will most likely include language from the House-passed Water Resources Development Act of 2020 (H.R. 7575), and the Senate Environment and Public Works (EPW) Committee-passed America's Water Infrastructure Act of 2020 (S. 3591) and Drinking Water Infrastructure Act of 2020 (S. 3590). Other items may also make it into the final WRDA package, including several water-related provisions from the House-passed \$1.5 trillion Moving Forward Act (H.R. 2); a reauthorization of the Clean Water State Revolving Fund; more than \$200 million for EPA's sewer overflow and stormwater reuse municipal grants; possibly more than \$50 million for EPA's Water Infrastructure Finance and Innovation Act (WIFIA) funding; millions for EPA's water infrastructure and workforce investment grants; and new funding to support clean water resiliency and watershed-based projects. Negotiations also continue on legislative items related to Bureau of Reclamation programs and projects for inclusion in the final WRDA bill as part of a Reclamation title.

Reclamation Bills

Aerial Snowpack Observatory (ASO)

Senator Dianne Feinstein (D-CA) and Congressman Josh Harder's (D-CA) bill, the Snow Water Supply Forecasting Program Authorization Act – which will authorize an aerial snowpack observatory program under the Bureau of Reclamation – continues to be included in conversations related to a potential WRDA Reclamation title. Our Federal Lobbyists recently spoke with congressional staff about funding strategies for flights this fall and in early winter 2021 as work on the Fiscal Year 2021 appropriations bills continue during the lame duck congressional session.

Wildfires

Wildfire legislation could receive consideration in the lame duck congressional session. The legislation receiving the most focus is the Emergency Wildfire and Public Safety Act of 2020, led by Senator Steve Daines (R-MT) and Senator Dianne Feinstein (D-CA) in the Senate, and Congressman Jimmy Panetta (D-CA) and Congressman Doug LaMalfa (R-CA) in the House. Our Federal Lobbyists also began discussions with congressional staff about the connection of ASO programs to wildfire mitigation and recovery activities.

COVID-19

Negotiations over another COVID-19 relief package, mainly between House Democrats and the White House, have not progressed far enough to result in an agreement before the November 3rd election. House Speaker Nancy Pelosi (D-CA) and White House chief of staff Mark Meadows blamed each other as to the cause of the delay. Speaker Pelosi said she's hoping to hear back from Treasury Secretary Steven Mnuchin soon regarding a list of concerns over a recent \$1.9 trillion GOP proposal.

The Senate adjourned after approving Supreme Court nominee Amy Coney Barrett, without a session scheduled until after the election. Both parties have said there could be an opening for a pandemic relief bill during the lame-duck session, although the size and timing will be dependent on the election outcome. President Trump and Speaker Pelosi have both indicated their desire to finalize the next COVID-19 relief package during the lame duck session.

Budget

FY 2021 Appropriations

The current Continuing Resolution (CR) expires on December 11th. To avoid a government shutdown, Congress will need to pass all Fiscal Year 2021 appropriations bills or another CR prior to that date. To date, the House has approved all Fiscal Year 2021 spending bills and the Senate none. Final negotiations on Fiscal Year 2021 appropriations will be a top priority during the lame duck congressional schedule. The results of the election will most likely drive the decision on whether or not the Fiscal Year 2021 bills will be taken up during the lame duck or if another short term CR will be approved extending funding into the spring of 2021 or later.

Regulatory

National Environmental Policy Act (NEPA)

Senator Mike Lee (R-UT) introduced a bill to reform the NEPA. The NEPA Legal Reform Act (S. 4829) would, among other things, make it more difficult for special interests to delay infrastructure projects through legal challenges. The legislation is the latest GOP proposal to codify some of the regulatory changes, like page and time limits for environmental reviews, that the Trump Administration has worked to implement through new rulemaking and guidance. NEPA, requires reviews for major Federal actions, including permits for a wide array of projects.

Specifically, the legislation would set a statute of limitations for NEPA claims, require a plaintiff to show personal "direct tangible harm," and require courts to consider the effects of stopping a project not only pertaining to environmental and public health considerations, but also employment and economic considerations. Democrats have registered strong opposition to any changes to NEPA in law or regulation.

REQUEST TO JOIN COALITION

The California Forestry Association (CFA) requests your participation in a coalition seeking to intervene in support of the U.S. Fish and Wildlife Service (Service) in a lawsuit brought by Sierra Forest Legacy, Defenders of Wildlife, and the Center for Biological Diversity regarding a decision by the Service that listing the California Spotted Owl (CSO) was not warranted under the Endangered Species Act (ESA).

Why This Matters:

The best available scientific information supports the decision of USFWS that listing of CSO is not warranted. Listing of this species will hamper efforts on private, state, and federal lands in California to take management actions to reduce wildfire risk and protect human health and safety, natural resources and the environment. As the fires burning throughout California show, such responsible land management is long overdue, and will be needed in the coming years more than ever. Examples of the negative impacts of listing the CSO abound. Listing the species would slow and raise the costs of:

- fuel break construction projects;
- fuels management/reduction projects;
- · timber harvesting projects, including thinning; and
- public infrastructure projects and land management actions to protect them.

More frequent and intense wildfires will result, harming human health and safety, natural resources and the environment:

- people will be injured and/or killed;
- homes and other structures will burn;
- water supplies will be polluted by runoff from burned areas;
- other essential infrastructure, such as electrical transmission facilities and telecommunication lines and towers, will be destroyed;
- habitat for species (including protected species) will burn;
- watercourses will be polluted;
- · forest carbon storage projects will go up in smoke; and
- emissions from fires will cancel out hard-won emission reductions from the electricity and other sectors.

The Lawsuit:

On November 8, 2019, the U.S. Fish and Wildlife Service (Service) determined listing of the California Spotted Owl (CSO) was not warranted under the Endangered Species Act (ESA). On August 24, 2020, Sierra Forest Legacy, Defenders of Wildlife, and the Center for Biological Diversity, challenged the Not Warranted listing decision in federal court in the Northern District of California. These groups allege the Service was arbitrary and capricious in not listing the species given (1) threats faced by the species, including wildfire; (2) information contained in the species' status review that support listing; and (3) the



declining status of the species within its range. The case is Sierra Forest Legacy et al v. U.S. Fish and Wildlife Service et al, No. 5:20-cv-05800-BLF, U.S. District Court Northern District of California. It is assigned to Judge Beth Lawson Freeman in San Jose.

Intervenor Status:

The California Forestry Association will seek status as an Intervenor in the case. Intervenor status will allow CFA to defend the decision of the Service and participate in any settlement discussions that may occur during the course of the case. We believe that data collected and provided to the Service affords a solid basis for its decision and we seek to protect the scientific process used to reach the conclusion.

The case was filed on August 24 and an initial Case Management Conference is scheduled for 11am on December 10. We intend to file intervention papers by November 5 so that we can participate in the conference.

The Coalition:

We are inviting others who could be impacted by a reversal of the Service's decision to not list the CSO to join us as part of a coalition that will seek intervenor status. Your name will appear on the court records and you will have access to information regarding the case but will not be expected to actively participate beyond submitting a declaration. You will also not be asked to contribute financially to this effort and there is no risk you would be held responsible for the other side's fees costs. Essentially, you will be affirming your support for the Service's decision. There likely will be a hearing in 2021 in San Jose which you would be welcome to attend, but you will not need to testify.

We reviewed Sierra Resource Conservation District's (SRCD) "Fresno Local Agency Formation Commission Change of Organization/Reorganization Application." The application indicates:

- 1. A desire by SRCD to annex all unserved areas northeast of Highway 99 in Fresno County adjoining existing District Boundary.
- 2. Provide resource conservation support to unserved portions within Fresno County northeast of Highway 99.
- 3. The reasons for this proposed increased Sphere of Influence and Annexation are as follows: the Sierra Resource Conservation desires to serve communities and rural areas that are not currently being served and represented in the conservation of important natural resources, while providing technical assistance, funding, services, education and/or information that can protect and enhance the natural resources for the benefit of those communities and rural areas.

Furthermore, the following are noted in SRCD's 2015-2020 Long Range Plan:

- 1. As of 1992, the primary purposes of the Resource Conservation District under Section 9001 (a) is to secure "the adoption of conservation practices including but not limited to farm, range, open space, urban development, wildlife, recreation, watershed, water quality, and woodland; to save the basic resources, soil, water, and air of the state from unreasonable and economically preventable waste and destruction."
- 2. Agencies at all levels of government have responsibilities to provide expertise and to otherwise assist and cooperate with the RCD on natural resource projects. This is strengthened by additional inter-agency Memorandums of Understanding [MOU]. The RCD is to provide local input and leadership and foster interagency cooperation and coordination on natural resource projects on both public and private lands.
- 3. SRCD's mission and function is to take available technical, financial, and educational resources whatever their source and focus or coordinate them at the local level to meet the present and future natural resource needs of the local land user.

SRCD maintains working relationships with Federal, State and County Agencies and Departments, non-profit organizations, educational institutions which have natural resource duties and responsibilities under law, and with public and private landowners to save the basic resources, soil, water, and air of the state from unreasonable and economically preventable waste and destruction.
- 5. Most effective conservation practices will involve both the public and private land ownerships. The SRCD can and does act as a liaison between the private landowner and a multitude of land use programs to meet natural resource objectives.
- 6. Groundwater issues are a recurring theme on private lands within the RCD, and are specifically addressed in the Fresno County General Plan.
- 7. Canals and irrigation districts on the valley floor provide agricultural water during the dry summer months. Their boundaries and practices can affect the SRCD conservation efforts.
- 8. Information on individual and community wells, County Service Area (CSA's for community water systems), waste water treatment is available from the Fresno County Environmental Health Department, and the Fresno County Community Development Department.
- 9. Groundwater and recharge capabilities of land on the Valley floor and the foothills are an important concern addressed in the Fresno County General Plan. Specifically discussed are the increased pressure on water resources and diminishing capacity for recharge caused by conversion of agricultural and rangeland to other uses.

- 2. That "this proposal is not consistent with the sphere of influence of the District, thereby necessitating the concurrent request for an expansion of the same to match the annexation request."
- 3. "The reason for this proposed sphere of influence expansion and annexation is to provide coverage for soils and water conservation education, outreach and projects through Tranquillity Resource Conservation District to primarily agricultural areas which have heretofore not had access to the same...."

E-Updates: Staff attended regional SGMA meetings to write status updates for the November SGMA E-News update.

Social Media: External Affairs staff members continued developing content via Hootsuite content manager across social channels. KRCD participated in ACWA's Water Professionals Appreciation Week seeing positive engagement and a feature in the ACWA newsletter.

Twitter:

KRCD's Twitter page saw a marginal increase in engagement in October compared with the previous period, but the account gained 8 new followers.



Facebook:

KRCD's Facebook page saw a 250% increase in engagement in October compared with the previous period. Because of Water Professionals Appreciation Week, twice the number of

posts were published during the month accounting for much of the increase. The page received 6 more fans.

KRCD's LinkedIn account gained 3 new followers. Engagement and reactions were relatively high thanks to job openings and staff highlights.

KRCD website: The KRCD website saw a 29% increase in users in October compared to September, although the average time spent on the website per user decreased by nearly 50%, 33% of users in October were new visitors. The website was mainly visited by users via organic search, like typing into google with search words (66%) and direct URL access (27%). The remaining 7% of visits were attributed to referral either from links on other websites or through social media.

My report on water quality policy and implementation, water resources, and Water Resources and Environmental Division activities was prepared this month with assistance from Debra Dunn, Eric Athorp, Soua Lee, Vincent Sambrano, Jose Soto, Sonja Thiede, Lori Werner, and Jarrett Winther.

WATER QUALITY

Kings River Water Quality Coalition (KRWQC or Coalition)

KRWQC Board Meeting


The KRWQC Board meeting was held on October 20th with updates provided on outreach, membership, Regional/State Water Board, Fill Stations, and Management Zone activities. Directors Chauhan, McKean, and Mendes were appointed to serve on the Kings Water Alliance Board to represent the Irrigated Lands Regulatory Program. The next meeting will be held on December 15th.

Fill Station Development and Construction

In September, the Hanford fill station averaged 65 gallons daily water usage. Weekly bacteria samples collected at the fill station in October resulted in absent results. Staff continue to implement solutions and modify maintenance schedules as necessary at the fill station.

In October, the Kerman Fill Station averaged 40 gallons daily water usage. Weekly bacteria samples collected at the fill station in October resulted in absent results. Outreach postcards to nitrate impacted areas will be mailed in November with additional mailings and marketing occurring December through January.

Coalition staff and consultants have been working with Tulare County to finalize a site plan and agreement for the Dinuba fill station located at the Dinuba Public Library. The County selected a temporary location for the Dinuba Fill Station and all necessary paperwork has submitted. The date of the presentation before the Tulare County Board of Supervisors is pending.



Nitrate Management Zones

Staff continue to work with legal counsel for the formation of a non-profit organization for the KRWQC Management Zone, now called the Kings Water Alliance. The initial non-profit board includes three ILRP representatives, two dairy representatives, one poultry representative, and one wine representative for the board seats. Further discussions with dischargers in or considering the management zone continue with the next meeting scheduled for early December. Additionally, the interim technical committee met on October 29, 2020, to discuss boundary delineation, coordination, initial assessment of groundwater conditions, and outreach. Another technical committee meeting will be held in December.

Isotope Study - Phase 2

As of October 2020, KRWQC staff are working to finalize the report with Dr. Brad Esser.

KRWQC Membership Activities

Invoices have been finalized and are being prepared to mail out to members by November 5^{th} . Applications are now being sent out to prospective members who have reached out to join.

Internal testing is currently underway by Coalition Staff for the new KRWQC member portal. Testing and final implementations will be completed no later than October 29^{th} for an anticipated launch to members on November 2^{nd} .

Web-Based Submittal Database

Web developers have made a test version of the member portal available to staff. Staff will review available functions for software bugs and design improvements that will be submitted to MLJ Environmental to implement, where reasonable, prior the site going live. Database frontends were provided to the Coalition so that member payments and contact information could be updated prior to invoices going out to members. Documentation for the payment systems Stripe was provided to developers and the function has since been implemented. This will enable members to pay annual dues online with a credit/debit card through the member portal.

KRWQC Outreach Activities

The Coalition sent out emails to all members with email addresses on file reminding them of the upcoming December 31, 2020 deadline to test domestic drinking water wells. All inquiries on this program should be directed to the Regional Water Quality Control Board. An email was sent to growers who successfully completed a KRWQC self-certification course directing them to the CURES website to fulfill the continuing education requirement if needed.

Surface Water Quality Monitoring Plan Revisions

No updates to the development of a revised Surface Water Monitoring Plan occurred in October.

Surface Water Quality Sampling Activities

Surface water samples were collected from two out of eight sites Manning Avenue and Jackson Avenue on Monday, October 19, 2020. Field sheets and photo documentation were collected at all sites including the six dry sites of Gould Canal, Tivy Valley, Lemoore Weir, Empire 2 Weir, Crescent Weir, and Stinson Weir.

Drain Survey Activities

The October drain survey was conducted on the 28th and 30th of the month. The upper river from Army Corp Bridge to Hwy 41 was assessed on the 30th. The South Fork and the North Fork drains were assessed on the 28th. Due to the sharp decrease in water deliveries the river only flows pass Reedley and the majority of drains were not discharging into the riverbed and isolated pools (Railroad bridge (east of Lemoore Naval Airbase) to Empire 2 Weir).

Groundwater Quality Trend Monitoring Plan

A meeting with the Regional Board to discuss the revised methodology for the Groundwater Quality Trend Monitoring Plan is anticipated in November or December. Upon approval of the revised methodology, the Coalition anticipates further modifications to the well network and sampling procedures for 2021.

Groundwater Quality Trend Monitoring Activities

The data templates for the 2020 sampling data have been completed for processing. After review, the results will be uploaded to GeoTracker.

Comprehensive Groundwater Quality Management Plan

The Groundwater Management Practice Implementation Report (GW MPIR) is a new submittal requirement due March 1, 2021 by all members and will be due every five years

thereafter. The GW MPIR reports management practices implemented by the Member to comply with Comprehensive Groundwater Quality Management Plan (CGQMP) requirements. A revision to the CGQMP will be drafted once the Groundwater Protection process is completed.

Southern San Joaquin Valley Management Practices Evaluation Program (MPEP) Committee

Few changes were reported by consultants regarding the Conservation Innovation Grant in October. Award announcements are still anticipated for November and coordinating cooperators for the research is ongoing. Discussions with other researchers have improved the study approaches to make the work more meaningful. Contract work for the 2021 FREP grant is underway. Analysis of the 2018 Nitrogen Summary Report data for inclusion in the existing dataset is underway. Work is progressing on the development of acceptable Applied/Removed and Applied – Removed ranges, which will eventually replace the Outlier methodologies. The key is determining acceptable Applied values for nitrogen for the various crops and growing conditions.

The Surface Water Expert Panel has released its draft report for comment. A meeting is scheduled in November to discuss the report and the comments received, and a final report is scheduled for December.

No significant activity for CV-SALTS was reported in September to the Committee.

KRWQC/KRCD serves as the Fiscal Agent for this Committee. (Participants: Kings, Kaweah, Tule, Kern, Cawelo, Westside, Buena Vista Coalitions).

Central Valley Salinity Alternatives for Long-Term Sustainability (CV-SALTS)

On October 22, 2020, the CV-SALTS Executive Committee met and the discussion centered on management zone implementation status and the Salinity Prioritization and Optimization study overview of workflow for technical tasks.

KRWQC/KRCD is the fiscal agent for this group. (Participants: Kings, Kaweah, Tule, Kern)

<u>Central Valley Groundwater Monitoring Collaborative (CVGMC)</u>

KRWQC data for 2020 is being reviewed and readied for upload to GeoTracker. The next conference call is scheduled for November 2^{nd} .

KRWQC/KRCD is the fiscal agent for this group. (Participants: Cawelo, Buena Vista, East San Joaquin, Kern, Kings, Kaweah, Kern, Westside, Westlands)

Regional Water Quality Control Board (RWQCB) Activities

Coalition members that had their membership cancelled due to non-payment in 2019 received letters from the RWQCB regarding their obligation to retain coverage under the General Order.

State Water Board Petition of the East San Joaquin General Order

The East San Joaquin and irrigated agriculture interests were petitioned, and hearings were conducted on September 4, 2020; Tess Dunham, Jennifer Spaletta and the California

Farm Bureau's Kari Fisher represented irrigated agriculture. The Court issued an order on October 23, 2020 and denied every claim and allegation in all three petitions.

WATER RESOURCES

Sustainable Groundwater Management Act of 2014 (SGMA)

DWR released the final SGM Grant Program's Round 1 Prop 68 Implementation Proposal Solicitation Package. Applications will be accepted through January 8, 2021 and only one application will be accepted per subbasin. \$26 million is available for critically overdrafted basins with a \$5 million award maximum. The Round 2 grant solicitation is anticipated to open in Spring 2022.

Groundwater Sustainability Planning (GSP) Related Activities

North Fork Kings Groundwater Sustainability Agency (GSA) Implementation
The North Fork Kings GSA has two policies including the GSA's Rules and Regulations and
Groundwater Banking Policy available for review and comment. The Rules and Regulations
will lay the foundation for monitoring, well registration, measurement, and data
management. The Banking Policy discusses the GSA's role in new project development.
Comments for 30 days and it is anticipated that the NFK Board will consider approval in
mid-December.

North Fork Kings GSA Grant Activities

Round 2, Invoice 7 was approved for payment by DWR on October 27, 2020.

South Fork Kings GSA Implementation

The South Fork Kings GSA has developed a Groundwater Data Protection policy to ensure data confidentiality as the GSA collects needed information from groundwater extractors. The Groundwater Data Protection Policy is currently in a 30-day comment period and comments will be accepted until November 18, 2020. The SFK GSA Board will consider adoption of the policy at the December meeting.

South Fork Kings GSA Grant Activities

Consultants are currently working to acquire the appropriate permits to begin the Aquifer Storage and Recovery pilot project; staff are continuing to work with the consultant to develop the project in the coming months. At the end of October there has been no major developments in this project.

California Statewide Groundwater Elevation Monitoring Program – SBx7 6 (CASGEM)

Data has been collected by KRCD staff on our monitoring well network, and data is being reported slowly from the other cooperating agencies. Follow up with those who have not reported data will take place mid-November.

KRCD Subsidence Monitoring

The Subsidence Monitoring Program cost-sharing agreement was revised and resent to the GSA's for final approval due to James GSA and McMullin Area GSA opting out of the KRCD program. We expect to hear from Central Kings GSA and King River East GSA after their Board meetings in November.

The 2020 subsidence survey, including SGMA network points and KRCD levee monitoring points, was completed in October with the exception of points located in the GSA's that

opted out of the cost-sharing agreement or have not yet executed the agreement. Staff have begun processing the collected data, documenting the survey, and reviewing the results.

Kings Basin Water Authority (KBWA)

Board of Directors

The KBWA Board of Directors held a meeting on October 21, 2020 via Microsoft Teams. The Board received staff reports, including an update on Management Zone formation in the Kings and Tulare Lake Subbasins; approved updates made to the KBWA highlight brochure; admitted Reclamation District 1606 as a new Interested Party; and approved the quarterly financial reports.

Advisory Committee

The next regular meeting of the KBWA Advisory Committee is scheduled for March 17, 2020.

Prop 1 Disadvantaged Communities (DACs) Involvement Grant

No activities for report.

Prop 1, Round 1 IRWM Implementation Grant

Fresno Metropolitan Flood Control District (FMFCD) completed review of the draft grant agreement and it was forwarded to DWR on October 20, 2020 for further review. FMFCD continues to review the sub-agreement between the KBWA and FMFCD.

Inter-regional and Statewide Coordination

The Santa Ana Watershed Project Authority and the Local Government Commission held a free virtual Summit on October 8, 13, and 14, 2020, to share strategies for engaging tribes and marginalized communities as learned through local implementation of the IRWM Disadvantaged Communities and Tribal Involvement Program. The Summit included panel discussions and breakout sessions.

Kings River Conservation District Grants

McMullin On-Farm Flood Water Capture and Recharge Project Staff assisted in the preparation of the quarterly grant reporting.

<u>Prop 84 Statewide Flood Emergency Response Grant Program</u> Staff assisted in the preparation of the quarterly grant reporting.

WATER RESOURCES DIVISION ACTIVITIES Geographic Information System (GIS) Projects

SGMA

Staff prepared the monitoring locations and templates for the fall groundwater sampling.

KRWQC

Survey data for the current trend monitoring sites is being compiled and will be sent to the consultant when complete.

Flood Maintenance

Staff surveyed levee centerline elevations upstream of 22nd Avenue on the right bank and sent the requested data to GEI. Staff completed the 2020 survey of the levee subsidence

monitoring locations and has begun to process the data. Work continues to digitize the Right-of-Way and easement paper files.

Other Programs

Staff created a map of the Resource Conservation Districts that overlap and/or are adjacent to KRCD. The Thorburn project permit was reviewed, including a site visit to determine the feasibility of the proposed plan. Staff answered questions and provided data in response to multiple inquiries from staff, stakeholders, consultants, and other districts.

ENVIRONMENTAL DIVISION

Fisheries Management Program (FMP)

Incubator Building

Potential volunteers were provided with information regarding the 2020-2021 rearing season. Volunteers were informed the rearing season would be reduced from three to two rearing periods in the incubator to avoid inappropriate water temperatures for trout eggs which typically occur during the late October, early November incubation period.

Additionally, volunteers were notified of new rules which have been mandated in response to COVID. All staff and volunteers participating in incubator activities will be required to adhere to social distancing guidelines as well as wear masks and gloves. Additionally, all volunteers will be required to sign a waiver releasing KRCD of liability due to COVID. The incubator is currently offline until December 2020, when operations will resume at the end of the month.

Proposed Habitat Projects

Three of the four habitat enhancement projects recommended by staff were selected by the TSC on October 20th for further proposal development by Cramer Fish Sciences. These projects include gravel augmentation below the Army Corps Bridge, creation of a side-channel on the right bank below Winton County Park, and restoration of the Thorburn spawning channel.

Electrofishing

Staff continue to work on generating a comprehensive electrofishing report for the years 2007-2019. Data from past years is currently in the process of being verified for accuracy and completeness. Upon completion of verification, data from multiple years will be combined into a master spreadsheet.

Executive Committee Meeting (ExCom)

ExCom did not meet in October. The next meeting is scheduled for November 5th via Zoom.

Technical Steering Committee (TSC)

The TSC met on October 20, 2020 and October 27, 2020. Three enhancement projects were selected by the TSC at the October 20th meeting. The October 27, 2020, meeting covered river and reservoir conditions, stocking information for the river, and an update on the number of potential incubator volunteers when operations begin in late December. The next regular meeting of the TSC is slated for November 24, 2020.

Public Advisory Group (PAG)

The PAG meeting was conducted via Zoom on October 20th. Discussions included river and reservoir conditions, CDFW and KRFMP stocking, and the enhancement projects selected by the TSC. The next PAG meeting is scheduled to occur via Zoom on November 17, 2020.

Stocking

Supplemental Stocking Plan

Supplemental stocking of rainbow trout by Calaveras Trout Farm (CTF) was scheduled to begin the week of October 26th. The decision was made to delay stocking for a week with the anticipation a weather change would bring more favorable water temperatures for trout. On October 22, 2020, a gate change was made at the dam resulting in releases from a higher level of the reservoir, and thus warmer water. Stocking will resume in November.

CDFW Annual Budgeted Stocking

Stocking by CDFW in the lower Kings River did occur in October and is expected to continue. However, the persistence of adverse temperature conditions for trout may result in delayed stocking until conditions improve in November. Since July 10, 2020, 360 brook trout (5,200 lbs), and 1,860 rainbow trout (1,000 lbs) have been stocked in the river.

FERC License Renewal – The DRAFT Boundary Adjustment Amendment public review period ended October 30, 2020. Monthly Status Report of Activities for the Month of October 2020

This is the monthly status report for the CFO for the month of October 2020, and includes input from the Finance, Human Resources and Admin Departments.

I presented financial reports at the meetings of the South Fork Kings Groundwater Sustainability Agency (SFKGSA), the North Fork Kings Groundwater Sustainability Agency (NFKGSA), at the bimonthly meeting of the Kings River Water Quality Coalition and the quarterly meeting of the Kings Basin Water Authority during the month.

Audits of the three GSAs (MAGSA, NFKGSA and SFKGSA) commenced in October and will be on the agendas for presentation as soon as each audit is completed. The audits are being performed by Cuttone and Mastro CPAs in Fresno. The audit of the Kings River Water Quality Coalition is in process as well. The KRCD audit is expected to be completed and presented at the December 8, 2020 board meeting.

Property tax bills that include the special assessments approved by the voters in the MAGSA, SFKGSA and NFKGSA areas were scheduled for mailing in late October by Fresno and Kings Counties. Billings for Water Quality Coalition member contributions were issued in the last week of October.


The District's last investment in commercial paper, corporate notes or bonds held at J.P. Morgan Securities matured in the month of October. The District has reinvested those funds in the Fresno County Investment Pool. The County Investment Pool offers the best yield while meeting the first two criteria of the investment policy, safety and liquidity.

Stacy Wright, Manager of Human Resources, attended various meetings, webinars, and training sessions to keep her understanding of ever-changing HR issues and laws up to date. Stacy completed the hiring process for a new External Affairs employee and provided an orientation to the successful candidate. She also began a recruitment for a Hydroelectric Power Plant Manager for the Pine Flat Power Plant. During the month Stacy administered the annual open enrollment period for health insurance and began preparing for the annual Section 125 Flexible Spending open enrollment.

KINGS RIVER CONSERVATION DISTRICT BUDGET TO ACTUAL COMPARISON




